**WHEREAS**, the staff of the Bureau of Securities Regulation, Department of State, State of New Hampshire (hereinafter referred to as "the Bureau") submitted a Staff Petition for Relief in the above-referenced matter on June 26, 2015; and

**WHEREAS**, an Order to Cease and Desist and an Order to Show Cause were issued by the Director of the Bureau on July 13, 2015, said orders containing a Notice of Order and a Notice of Right to Request a Hearing; and

**WHEREAS**, a copy of the Staff Petition and Orders were sent to the Respondents via U.S. certified mail to the Respondent at 230 Meadow Street, Shelton,

CT 06484 and, according to United States Postal Service Tracking, were delivered on July 27, 2015 at 2:13 p.m.; and

**WHEREAS**, having been duly notified, the Respondent failed to request a hearing within 30 calendar days of the receipt of the Staff Petition and Orders; and

**WHEREAS**, the Bureau submitted a Motion for Default on September 1, 2015;

### **ORDER**

THEREFORE, it is hereby ORDERED that:

- 1) The Respondent is found in default of the Order to Cease and Desist and the Order to Show Cause in the above referenced matter;
- 2) The Order to Cease and Desist is made permanent pursuant to N.H. RSA 421-B:23, and the Respondent shall cease and desist from violations of N.H. RSA 421-B.
- 3) The Respondent's broker-dealer agent license is hereby revoked pursuant to N.H. RSA 421-B:26, III and RSA 421-B:10.
- 4) The Respondent shall pay administrative fines and penalties of \$50,000 to the Bureau pursuant to N.H. RSA 421-B:3, RSA 421-B:3-a, RSA 421-B:10, RSA 421-B:11, and RSA 421-B:26, III.
- 5) The Respondent shall pay investigation costs of \$50,000 to the Bureau pursuant to N.H. RSA 421-B:22.

- 6) The Respondent shall pay restitution of \$7,123.00 to Investor #1 as referenced in the Bureau's Staff Petition for Relief in this matter.
