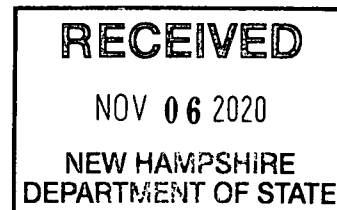

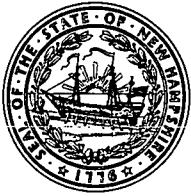



Section V
