Political barriers have stalled further action, and Congress has shown little enthusiasm for financial support to state and local election offices to protect their voting processes. The sprawling multi-level election apparatus across the country often relies on local personnel with little to no advanced knowledge or appropriate resources to digitally secure electoral systems.
