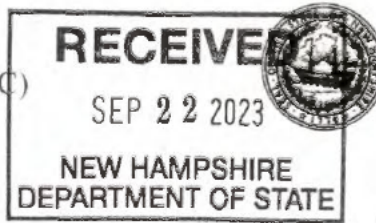

### **1. THE BENEFITS AND COSTS OF EXPANDING EARLY CHILDHOOD EDUCATION AND CHILD CARE**

Early childhood education is a core component of building strong communities, preparing children for the future, and supporting working parents. As more parents seek quality early childhood education, costs have risen sharply, and policymakers are being pushed to find ways to expand access, increase quality, and simultaneously improve affordability and educator pay and working conditions.

This session presents a facilitated discussion on existing childhood education models in various states and provinces and the outcomes of these services. Attendees can discuss costs, strategies, and policy implications with panelists and are encouraged to share changes and innovative solutions from their own jurisdictions.



### **2. HOW CAN EXPANDING WORKFORCE PIPELINES ADDRESS LABOR SHORTAGES?**

These systems can also improve employment outcomes for people of color, individuals with disabilities, and rural and low-income workers.

This session outlines various work-based learning opportunities being deployed in the region and around the continent for students and job-seekers of all kinds. Open discussion will follow a moderated panel. Attendees will be invited to share examples from their province or state, ask questions, and contribute to this region-wide dialogue.

In addition to the update on rail safety measures, attendees will be invited to participate in a dialogue on what their provinces and states have considered for advancing rail safety.

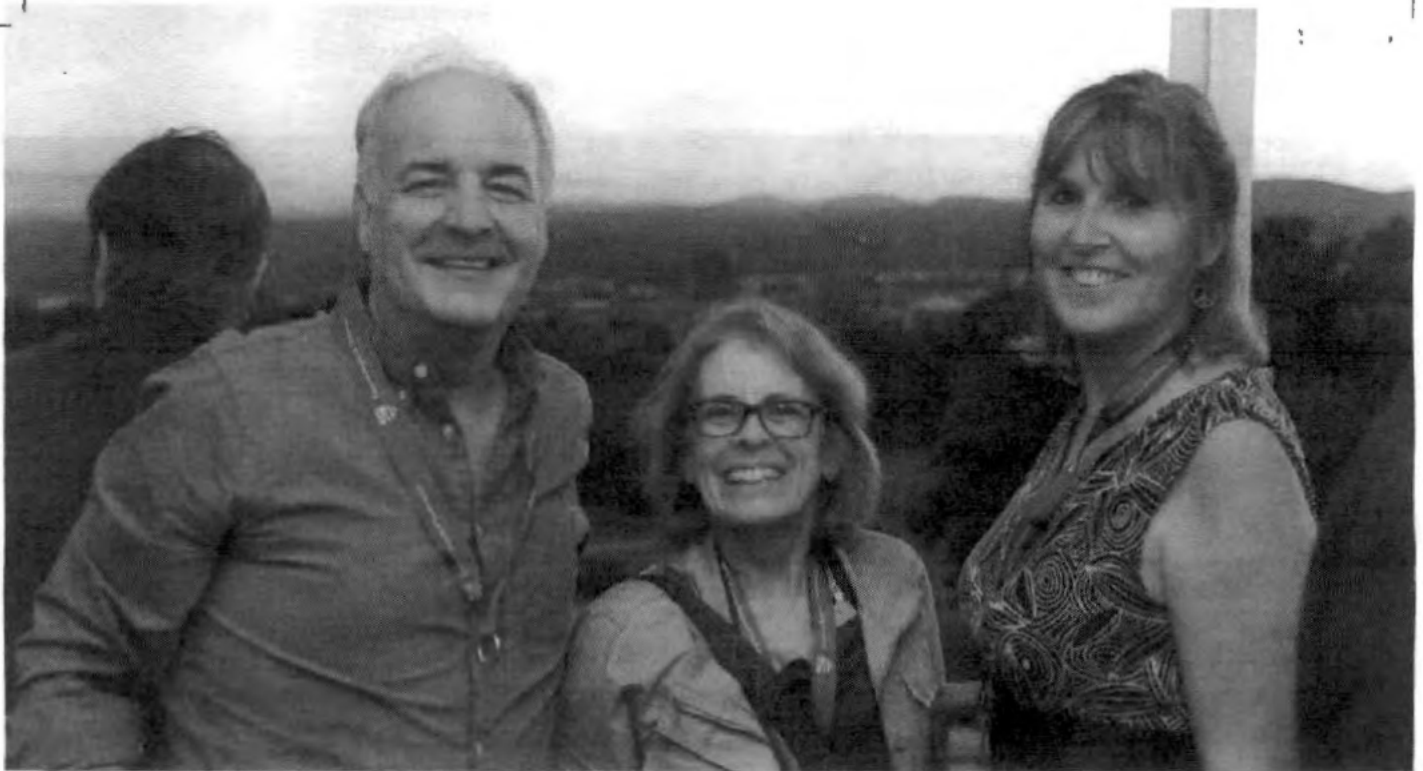

There is general agreement that meeting U.S. and Canadian carbon-reduction goals will require a rapid shift from technologies powered by fossil fuels to those powered by clean energy – a process known as electrification. While the region has made strides in ramping up large-scale renewables and developing an electric vehicle infrastruc-

ture, moving away from fossil fuels in the built environment – which generates nearly 40% of annual global emissions – has proven more complex.

This session will explore best practices for incentivizing building electrification, particularly in existing buildings in underserved communities, whose residents are most likely to face high energy burdens and the negative health effects of indoor air pollution.

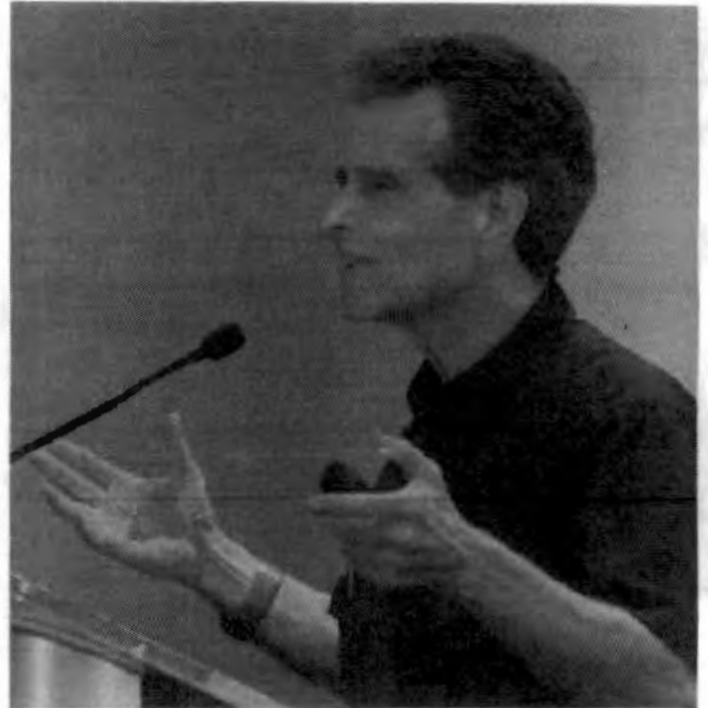

A growing, tragic dilemma confronts the U.S. and Canada, with millions of people experiencing mental illness and substance abuse problems every year. In any given year, 1-in-5 people in Canada and the U.S. will personally experience a mental health issue with significant physical, social, and economic consequences. It is estimated that 50% of the US population will experience mental illness at some point in their lives. Many state-level policies — health, housing, criminal, and educational — are essential to improving mental health outcomes and reducing the growing burden of mental health issues on individuals, communities, and states/provinces. The COVID-19 pandemic focused greater attention on this growing problem, particularly the increase of mental health problems among adolescents and young adults. States are playing a major role, developing policies to address the prevention and treatment to improve mental health and reduce the impact of mental illnesses. Policies for expanding Medicare coverage, addressing social determinants, global budgeting, and expanding reimbursement are among the policy approaches. Join U.S. and Canadian officials to discuss the unique challenges and innovations that emerged in 2023.

The COVID-19 pandemic strained the healthcare systems in the U.S. and Canada in terms of human and economic costs. In a recent survey, only 18 percent of Canadians believed the health care system was working well and 54 percent believed change was needed. Lack of federal funding and inefficient provincial management were named as causes of the problem. A U.S. Gallup Poll survey had similar results, showing that 70 percent of Americans felt the health system was "in a state of crisis" or having "major problems." Access and inequitable health services, insurance coverage, and costs of care were cited as major issues.

Many states and provinces are identifying causes of the problem and developing funding, organization, and care delivery policies and regulations to bring about needed change. This session provides a forum to learn from other states and provinces about their policy and regulatory innovations for funding, cost containment, equity, etc.

In every region of the U.S. and Canada, a worsening housing crisis is threatening to put homeownership out of reach for many, squeeze family budgets for renters and homeowners alike, and push thousands into emergency shelters or onto the street. The lack of housing supply, especially affordable housing, is now driving

negative outcomes in education, health, and employment as well. In 2021, nearly one-third of all U.S. households – and half of all renters – spent more than 30 percent of

their income on housing, which is considered the threshold for being “cost burdened.” In Canada, the situation is no better. More than 20 percent of Canadian households exceeded this affordability benchmark in 2021, including one-third of all renters.

Join policy experts from the United States and Canada to discuss strategies for better aligning efforts to improve access to affordable housing with actions to decrease homelessness, remove barriers to housing assistance, and strengthen partnerships with local communities.

## Hon. Sheila Oliver, Lieutenant Governor

NEW JERSEY

Sheila Oliver was first elected to the New Jersey Assembly in 2004, and in 2010 she became the first Black woman to serve as Assembly Speaker. In 2018, Oliver was elected Lieutenant Governor, becoming the first African American to hold statewide office in New Jersey. Oliver was an active member of the CSG East Executive Committee during her tenure in the Legislature, and served on the host committee for the 2012 Annual Meeting in Atlantic City.



## Sen. Mary Ellen Goodwin

RHODE ISLAND

Sen. Mary Ellen Goodwin was first elected to serve Rhode Island Senate District 1 in 1987 and served until 2023. Her many legislative accomplishments include work in health care and quality elder care on behalf of underprivileged Rhode Islanders. Goodwin, who also served as Senate majority whip, was a good friend of CSG East who served as regional co-chair and co-chair of the annual meeting in 2000. She served on the CSG East Executive Committee for 23 years.

Rep. Steve Kulik served the Massachusetts 1st Franklin District from 1993-2019. 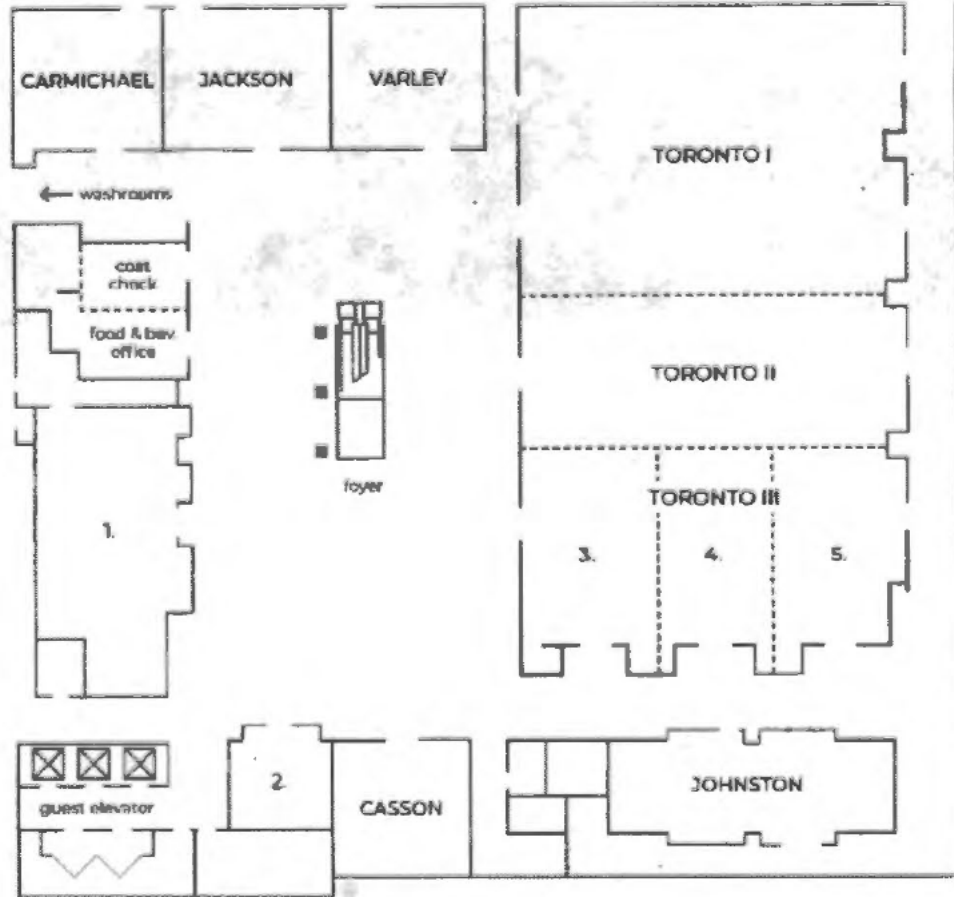

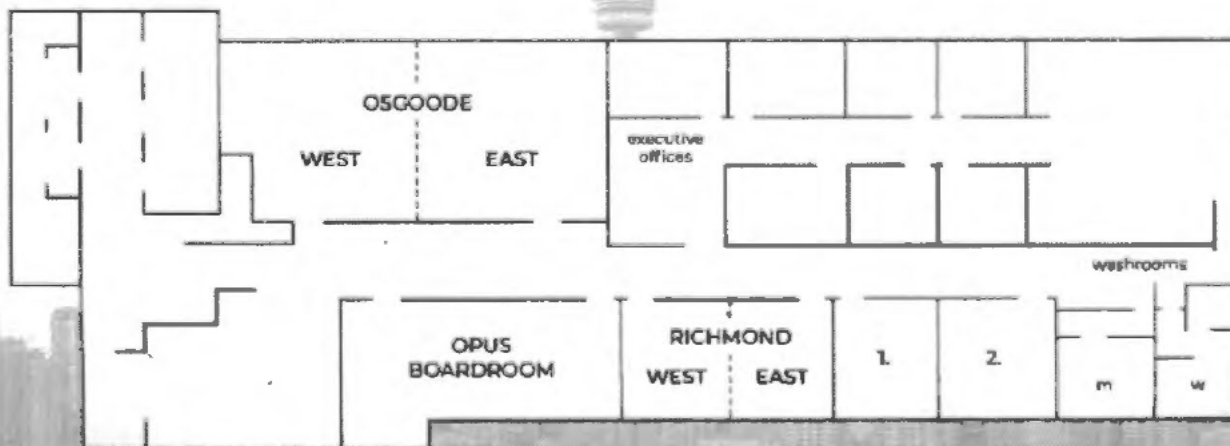
