First, our communication technology, Opentok stores all recordings and notarial act data for one month. We also have a running backup for the length of 10 years through our AWS S3 bucket. In addition, all notaries on our platform are required to store backup data on their own servers

for the duration of their commission. In the event NotaryLive is going out of business, we would notify all parties involed in advance that backup copies will need to be downloaded by a certain data and released to the Secretary of State. It is also important to note, we have prepaid for the storage

through AWS for the term of the agreement

By submitting this application, the Provider agrees to:

- 1. Comply with the laws that govern New Hampshire Notaries Public and Justices of the Peace.
- 2. Promptly notify the New Hampshire Department of State of any change in technology that places the Provider out of compliance with any applicable New Hampshire law or industry regulation.
