DocMagic allows notaries to provide their own digital certificate if they have one issued to them by a certificate authority which is compliant with the X.509 standard, or will apply its own digital certificate compliant with the industry X.509 standard.

Question 4 – Describe plan for disposition of data in the event the provider no longer provides storage.

DocMagic intends to make all such data available, including provisioning for such availability, in the event it no longer provides the DocMagic Total eClose platform or in the event of dissolution of DocMagic's business. Journal information and recordings are made available to the remote notary for download and storage in their electronic journal. Additionally, in the event DocMagic ceases business operations, it will notify the secretary of state in advance of such cessation in order to facilitate any release of any record to the secretary of state.
