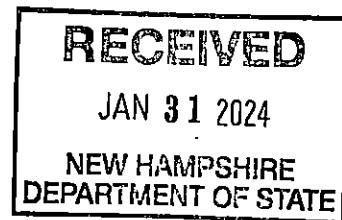

\*Attachment to Addendum A, Section V
