Stavvy video streams are recorded in-full and persisted within Stavvy's AWS-based long-term data stores (encrypted using the SHA-256 algorithm) for a minimum of 10 years or longer upon customer request. To access these video files, only authorized users (such as the notary who conducted the remote notarization act), can log in to Stavvy via email, password, and a 6-digit one-time verification code sent either to their email or phone. These authorized individuals can produce the recording by downloading an .mp4 video file directly from the Stavvy web interface. The notary journal is also available within a similar interface. Stavvy maintains an electronic record of all data that would otherwise be stored in a traditional journal, which can only be accessed via the email, password and 6-digit verification mechanism. The system tracks the exact date and time when each notarial act is performed, which is available as part of an audit trail. Stavvy stores all documents and records associated with the electronic journal for a minimum of 10 years. In the event of Stavvy no longer being able to provide the above capabilities for any reason, we would notify all customers and provide access to export these assets for a reasonable period of time.

By submitting this application, the Provider agrees to:

- 1. Comply with the laws that govern New Hampshire Notaries Public and Justices of the Peace.
- 2. Promptly notify the New Hampshire Department of State of any change in technology that places the Provider out of compliance with any applicable New Hampshire law or industry regulation.
- 3. Prohibit the use of any eNotarization or Remote Notarization system for any New Hampshire Notary Public or Justice of the Peace whose commission is no longer active.
- 4. Promptly notify the New Hampshire Department of State by re-submitting this form if any information provided herein changes during the period in which the Provider is doing business in New Hampshire and indicate the change that has occurred.
