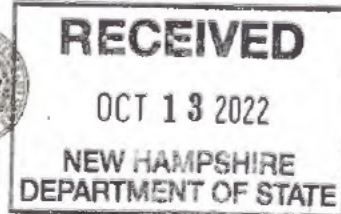

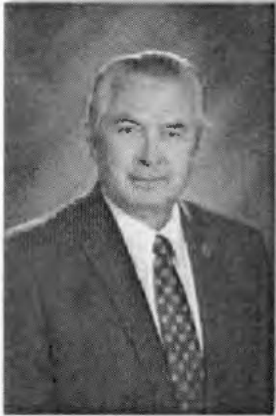

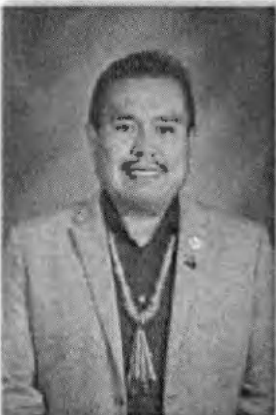
## Participating Legislators 2022 Clean Energy Legislative Academy

### ARIZONA



#### **FRANK CARROLL, REPUBLICAN REPRESENTATIVE**

Representative Frank Carroll is the Chairman of the Committee on Transportation in the House of Representatives in the State of Arizona, and serves on the Natural Resources, Energy and Water, and Government and Elections Committees. Originally from Chicago, Illinois, Representative Carroll worked in the automobile industry his entire career, specifically in technology of ground transportation vehicles. Representative Carroll assumed office in January 2019, where he represents Arizona State House District 22.



#### **MYRON TSOSIE, DEMOCRATIC REPRESENTATIVE**

Representative Myron Tsosie, 39 years of age, Diné, of the Coyote Pass Clan born for the Towering House People, maternal grandparents are of the Towering House and paternal grandparents are of the Water Flows Together People. Representative Tsosie currently resides in Chinle, Arizona in the Heart of the Navajo Nation. Since 2014, he has served on the Chinle Unified School District School Board and continues to do so to this day where he works with local, state, and national leaders both in the Arizona State House and Senate.

### ARKANSAS



#### **DENISE ENNETT, DEMOCRATIC REPRESENTATIVE**

Representative Denise Ennett is serving her second term in the Arkansas House of Representatives. For the 93rd General Assembly, Representative Ennett serves on the House Public Transportation Committee, the Joint Committee on Advanced Communications and Information Technology, and the House Committee on Agriculture, Forestry and Economic Development. She earned a Bachelor of Arts in History from the University of Texas at Arlington and a Master of Arts in Higher Education/College Affairs from UA-Little Rock. Arkansas is a rural state, which makes it perfect for renewal energy. Recently, Representative Ennett ran a bill to have all seventy-five counties create a standard way of assessing solar equipment.

Representative Shelly Hutchinson began her lifelong career in social services and child welfare working for Child Protective Services in 1993. In 2002, Representative Hutchinson founded the Social Empowerment Center, a mental health and social services outreach and treatment center in Lawrenceville, Georgia. In 2014, Representative Hutchinson and the Social Empowerment Center were recognized by the "Bulldog 100" as the #1 fastest growing business owned or operated by a University of Georgia alumni. Representative Hutchinson also became a part-time professor at the UGA School of Social Work.

### **MESHA MAINOR, DEMOCRATIC REPRESENTATIVE**

Representative Mesha Mainor is an Atlanta native legislator representing the heart of Georgia. Representative Mainor passed legislation to make communities sustainable through renewable energy, technology, and 4IR workforce development. Representative Mainor is willing to cross party lines to accomplish her priorities of child advocacy, education, human rights, victim rights, sustainability, and economic development. She is a mom of two girls; she graduated with a Master's degree in physical therapy from Howard University; and she is currently working on a doctorate in business.

## ILLINOIS

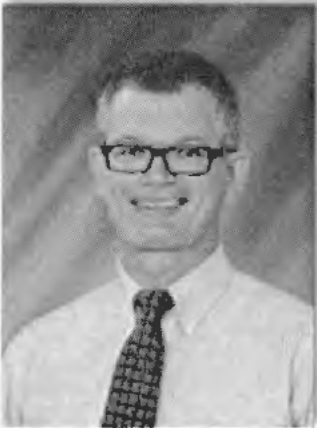


### **SUE REZIN, REPUBLICAN SENATOR**

Senator Sue Rezin has served in the Illinois State Senate since 2010. In 2021, she was chosen as Deputy Minority Leader for the Senate Republican Caucus. Senator Rezin currently serves as the Minority Spokesperson on the Senate Energy and Public Utilities Committee. She is also a member of the Senate Executive Committee, as well as a member of the Joint Committee on Administrative Rules. For the past two years, she served as the Illinois Senate Republicans' point person for negotiations related to the recently passed comprehensive energy legislation.

On a national level, Senator Rezin is member of the National Conference of State Legislatures (NCSL), currently serving on NCSL's 63-member Executive Committee and Task Force on Energy Supply. She also serves on the National Foundation for Women Legislators' (NFWL) Board of Directors, which she joined as an At-Large Member in 2021. Senator Rezin is a graduate of Harvard University's Kennedy School of Government's Senior Executives in State and Local Government Program. Recently, she was chosen as one of the 2020 Women of Excellence Award honorees by the National Foundation for Women Legislators.

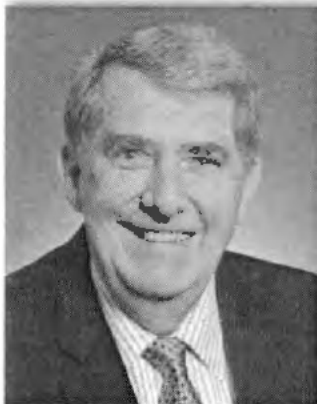
## IOWA

### **JERRY NEWTON, DEMOCRATIC SENATOR**

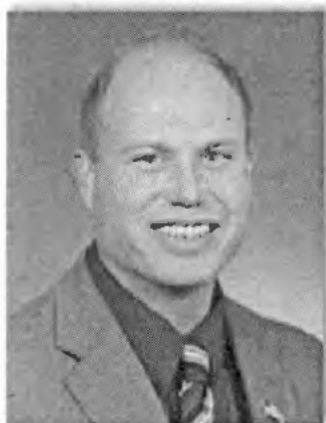

Senator Newton has served six years on the Coon Rapids City Council, eight years on the District 11 School Board, six years in the Minnesota House, and six years in the Minnesota Senate. Senator Newton serves as the Vice Chair on the Veterans Committee, and as a member of the Energy and Utilities Committee and the Minnesota Trust Lands Committee. His focus is on renewable energy, safeguarding the environment, and clean water.



### **MARION O'NEILL, REPUBLICAN REPRESENTATIVE**

Representative Marion O'Neill is in her 5th term in the Minnesota House of Representatives. She serves a district that is home to the Xcel Monticello Nuclear Power Plant and lives very near the SHERO coal plant. Representative O'Neill served on the Energy Committee of the House of Representatives for four years and has served on the Legislative Energy Commission (LEC) for the four years after that. She has studied energy production and policy extensively over the course of her tenure.

### **JASON RARICK, REPUBLICAN SENATOR**

Senator Jason Rarick served in Minnesota House for four years and has been in the Minnesota Senate for four years. Senator Rarick is a member of IBEW 110, and he has been a union electrician since 1992 and an electrical contractor since 2004, specializing in temperature controls. Senator Rarick has served on the Energy committee for six years, and carried a number of bills in that arena, including the ECO act, which was a major reform of Minnesota statute regarding conservation improvements.

## MISSISSIPPI



### **RONNIE CRUDUP, JR., DEMOCRATIC REPRESENTATIVE**

Representative Ronnie Crudup Jr. represents Mississippi House District 71. Representative Crudup's committees are Transportation, Municipalities, Public Property, Energy, and Public Health. He is married with three children, and is a graduate of Belhaven University, with a degree in History. Representative Crudup is also the Executive Director for a nonprofit in Jackson, Mississippi that focuses on issues such as housing, youth sports and arts, and childcare and aftercare. He is currently in his fourth year in the Mississippi Legislature, and he has been Executive Director of the nonprofit for over eight years.

## NEVADA



### **DALLAS HARRIS, DEMOCRATIC SENATOR**

Senator Dallas Harris serves as a state Senator for Nevada's 11th District. Outside of legislative service, Senator Harris works as an attorney at Davison Van Cleve, where she practices energy law. Her legislative priorities include criminal justice reform, economic development, and cannabis regulation. She currently serves as the Chair of the Senate Committee on Growth and Infrastructure and as a member on the Judiciary and Health and Human Services Committees.



## NEVADA, CONTINUED



### **CAMERON "C.H." MILLER, DEMOCRATIC ASSEMBLYMAN**

Assemblyman Cameron "C.H." Miller represents Assembly District 7 in the Nevada Legislature. During the 81<sup>st</sup> Legislative Session, Assemblyman Miller served on the Growth and Infrastructure, Judiciary, and Revenue Committees. ### **REBECCA PERKINS KWOKA, DEMOCRATIC SENATOR**

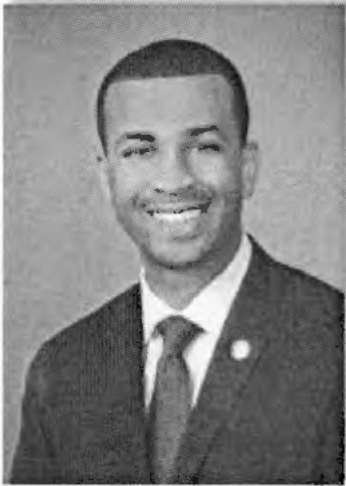

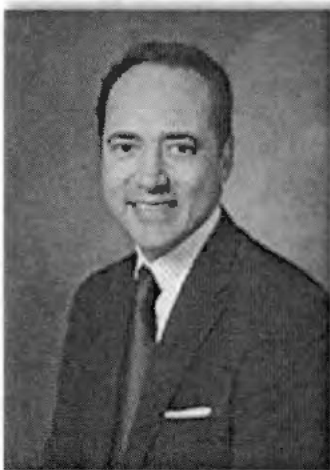
## SOUTH CAROLINA

## ENERGY STORAGE AND RENEWABLES

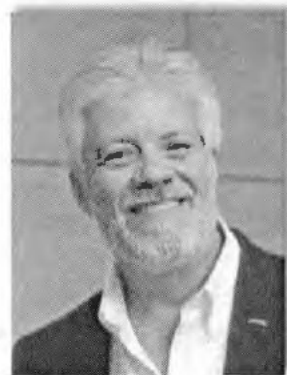
The energy storage and renewables workshop will focus on policies to promote greater market penetration of energy storage technologies and mainstream renewable adoption. The workshop will provide an overview of the various value streams that should be considered when developing energy storage policies. The workshop will also include a discussion of costs and benefits to the energy system and market drivers for utility-scale and customer-sited energy storage. In the past decade, the costs of renewable resources have dropped dramatically, making them not only the lowest pollution resources, but also, in many cases, the least expensive resources. This workshop will highlight the next generation of renewable energy policies to reduce barriers to both consumer and utility participation in the renewable energy market.

## MODERNIZING UTILITIES AND EMPOWERING COMMUNITIES

This workshop will look at policies to advance a more modern and intelligent grid to enable customers to save on their bills and take advantage of clean energy technologies like rooftop and community solar and storage projects. It will also cover the role of state legislatures in unlocking more modern approaches utility regulation to facilitate investment and customer participation in a cleaner, cheaper, more resilient grid.

**Legal Counsel for Transportation Equity, The Greenlining Institute**

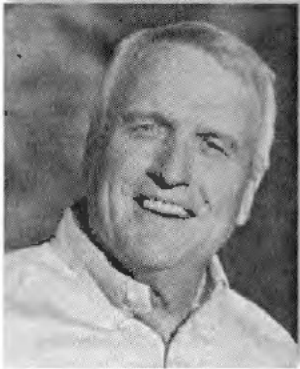

#### **BILL RITTER**

##### **Director, Center for the New Energy Economy**

Bill Ritter, Jr. is the founder and director of the Center for the New Energy Economy (CNEE) at Colorado State University, which launched on February 1, 2011.

Governor Bill Ritter was elected Colorado's 41st Governor in 2006 and was the District Attorney of Denver from 1993-2005. During his four-year term as Governor, he established Colorado as a national and international leader in clean energy by building a New Energy Economy. After leaving the Governor's Office, Governor Ritter founded CNEE, which works with state and federal policymakers to create clean energy policy throughout the country. Governor Ritter authored a book that was published in 2016

entitled, *Powering Forward – What Everyone Should Know About America's Energy Revolution*.

Governor Ritter was formerly the chair of the Board of Directors of the Energy Foundation and currently serves on the Board of the Climate Group and the Board of Trustees of The Nature Conservancy. Governor Ritter is a member of Blackhorn Venture Capital and serves as an advisor to Green Alpha and Project Canary, among others. He earned his bachelor's degree in political science from Colorado State University (1978) and his law degree from the University of Colorado (1981). With his wife Jeannie, he operated a food distribution and nutrition center in Zambia.



#### **CECILIA MARTINEZ**

#### **Senior Project Leader, National Renewable Energy Laboratory**

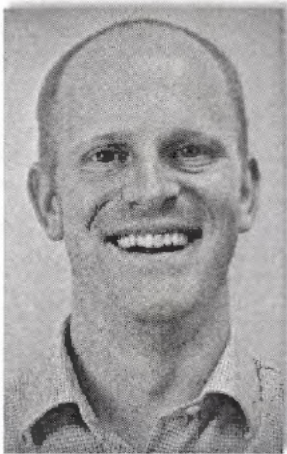

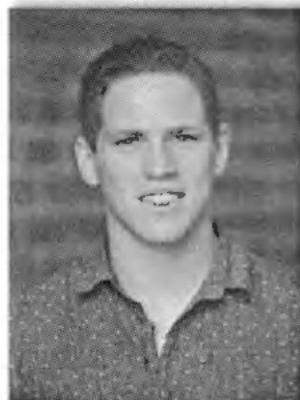
### **EVELYN PETERSON, ADMINISTRATIVE COORDINATOR**

### Avoiding Altitude Sickness

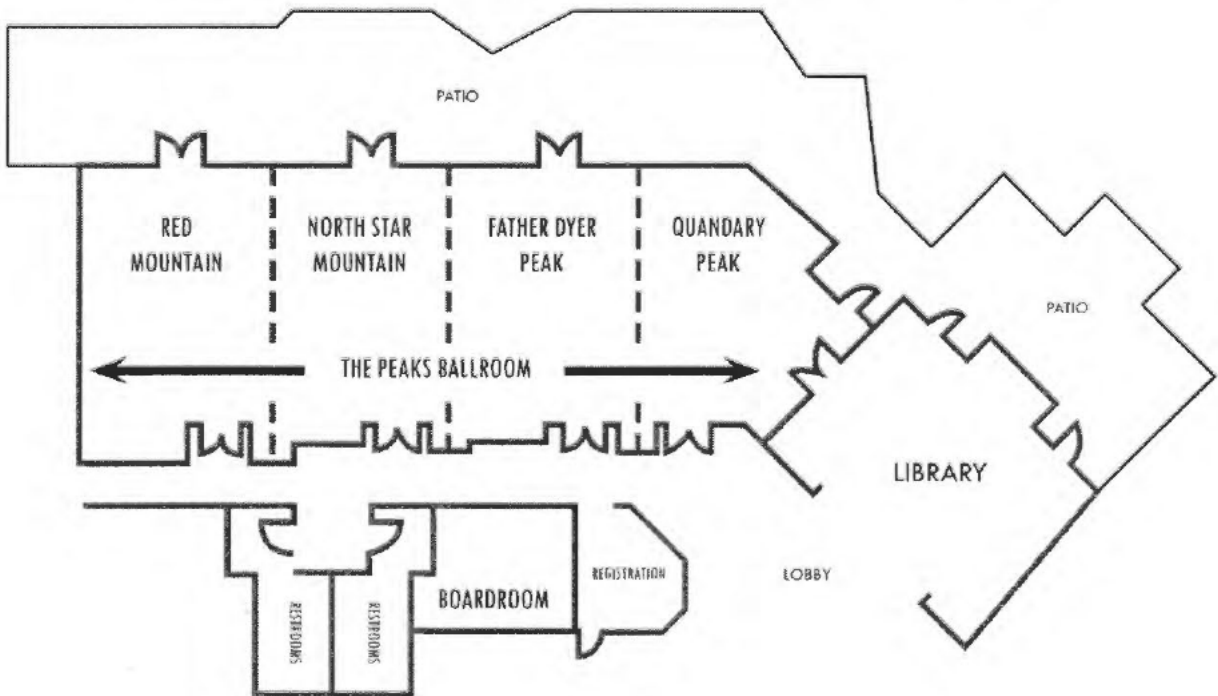
Altitude sickness is a very real thing and it can affect anyone, regardless of age or fitness level. Symptoms include shortness of breath, rapid pulse, fatigue, headache, insomnia, and digestive issues. It can feel a little bit like the flu or a hangover and can be exacerbated by jet lag.
