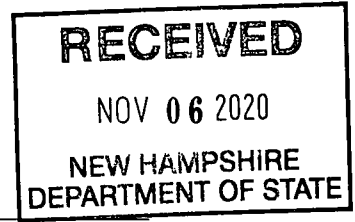



Section V
