EXECUTIVE ORDER 2002-5

An order directing a reduction in Executive Branch expenditures

WHEREAS, RSA 9:16-b provides that "Notwithstanding any other provision of law, the governor may, with the prior approval of the fiscal committee, order reductions in any or all expenditure classes within any or all departments, as defined in RSA 9:1, if [she] determines at any time during the fiscal year that: (a) projected State revenues will be insufficient to maintain a balanced budget and that the likelihood of a serious deficit exists;" and

WHEREAS, I have determined that the budgeted state revenues for Fiscal Year 2003 are insufficient to fund the state budgeted expenditures as authorized by Chapter 130, N. H. Laws of 2001; and

WHEREAS, the Governor and Legislature are committed to taking such steps as are required to achieve a balanced budget by the end of the biennium; and

WHEREAS, the Governor has determined that it is in the public interest to meet with the legislative fiscal committee, which has, in turn, responded to the Governor's initiative by consenting to certain actions to reduce executive branch expenditures;

NOW, THEREFORE, I, JEANNE SHAHEEN, Governor of the State of New Hampshire, by virtue of the power and authority vested in me by RSA 9:16-b and part II, article 41 of the New Hampshire Constitution, do hereby order effective immediately:

a. The General Fund appropriations as authorized for the fiscal year ending June 30, 2003 for each department listed below are hereby reduced by the amount indicated.

Any exceptions granted by the Governor shall be transmitted to the Fiscal Committee.
