


REQUESTED ACTION

The Department of Cultural Resources, Division of the Arts, requests permission to award Public Value Partnership Grant in the amount of \$11,000.00 to the Pontine Theatre, Portsmouth, to strengthen their capacity for affordable diverse arts programs to New Hampshire residents and visitors, effective upon Governor and Council approval through June 30, 2014. 100% Federal Funds.

Funds are available in the account titled Federal Arts Partnership Grant as follows:

EXPLANATION

Public Value Partnerships are awarded to nonprofit arts organizations, with a minimum of 5 years of continuous arts programming and professional staffing, to strengthen their capacity for offering affordable, diverse arts program to New Hampshire's residents and visitors. Grant categories and deadlines are advertised through the divisions' website, social media and electronic newsletters.

At a recent meeting, the Arts Council Board unanimously voted to accept the Arts Division's Public Value Partnership Review Panel's recommendations for the partnerships based on its funding priority ranking within a competitive review. The six-member peer panel, facilitated by an Arts Councilor, considered 17 criteria to arrive at a consensus ranking for each application. Each panelist is advised, both individually and collectively, of their obligation to disclose any conflict of interest and themselves from assessment if a conflict is present. The evaluative criteria range from the administrative capacity of the organization, artistic quality, strategic planning, to community impact and accessibility.

Should Federal Funds become no longer available General Funds will not be requested to support this program.

This agreement between the State of New Hampshire, New Hampshire State Council on the Arts (hereinafter "Council") and Pontine Theatre (hereinafter "Grantee") is to witness receipt of funds subject to the following conditions:

- 1. GRANT PERIOD: FY2014/2015

- The Grantee agrees to provide up to two (2) complimentary tickets/admissions as requested for site visits by appropriate Council staff/evaluators.
- The Grantee agrees to abide by the limitations, conditions and procedure outlined herein and in the attached appendices. If appropriated funds for this grants program are reduced or terminated, all payments under this grant may cease. That determination rests within the sole discretion of the Council.
- 3. PAYMENT will be made following the receipt and execution of all required documents and approval of the Governor and Executive Council
- 4. FINAL REPORT: The Grantee agrees to submit a final financial and narrative report on a form provided by the Council no more than 30 days after the end of the grant period. Failure to submit the final report will render

Pontine Theatre

Pontine Theatre is an artist-run organization. All aspects of program administration are overseen by the company's co artistic directors:

M. Marguerite Mathews, Founder and Co-Artistic Director of Pontine Theatre, holds a degree in theatre from Michigan State University. She studied with the great French actor, Etienne Decroux, at his L'Ecole du Mime Corporeal in Paris, France. She also worked with Thomas Leabhart at the University of Arkansas and at the Valley Studio in Spring Green, Wisconsin, before founding Pontine Theatre in 1977. She served a four-year term as President of the National Movement Theatre Association and a five-year term as editor of its publication, Movement Theatre Quarterly. Ms. Mathews has served two three-year terms as a panelist for the National Endowment for the Arts and as an onsite reporter for the Endowment. She has served on numerous state and local panels and is a two-term New Hampshire Artist Laureate Emerita.

Gregory Gathers, Co-Artistic Director of Pontine Theatre, holds a BFA from the Cleveland Institute of Art. He learned theatrical design working at Theatre by the Sea, in Portsmouth, NH and Tracy Costumes, in Boston, MA. He has been designing and constructing Pontine's costumes, sets, puppets and props since 1982, and has collaborated with Ms. Mathews on the development and performance of Pontine's original works since 1984. Mr. Gathers has served as an onsite reporter for the National Endowment for the Arts, as design director for the Movement Theatre Quarterly, and on several panels at the New Hampshire State Council on the Arts.


