To Her Excellency, the Governor, and the Honorable Executive Council:


In accordance with RSA 230:14, and RSA 230:45, I, Christopher D. Clement, Sr., Commissioner of the New Hampshire Department of Transportation, propose the reconstruction and expansion of NH 101 in the Town of Bedford at the locations given below:

**Bedford X-A000(143)**

This project will reconstruct and expand NH 101 to improve traffic operations and safety. The reconstruction of NH 101 will begin at Wallace Road and extend east approximately two miles to NH 114, and will widen the highway to provide two travel lanes both eastbound and westbound, a curbed center median, and sidewalks. The reconstruction will also entail improvements to the signalized intersections of Nashua Road, Meetinghouse Road, and Old Bedford Road/Constitution Drive.

This project will impact historic resources and wetlands.

Therefore, in accordance with RSA 230:14 and RSA 230:45, I, Christopher D. Clement, Sr., Commissioner of the New Hampshire Department of Transportation, propose the reconstruction and expansion of NH 101 in the Town of Bedford.
