Pursuant to RSA 94:1-d Allocations Decisions and RSA 94:1-a Salaries Established, the Liquor Commission respectfully requests authorization to establish a salary of \$104,729.35, Salary Grade HH, Maximum Step for Mr. Michael R. Milligan, Deputy Commissioner of the NH Liquor Commission, Position # 9U136 effective upon Governor and Council approval. Funding 100% Liquor Funds.

EXPLANATION
