

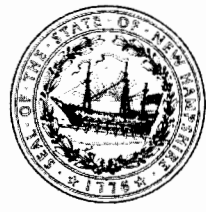

Your Excellency and Members of the Council:

REQUESTED ACTION

Authorize the Department of Justice to accept and expend a \$3,000 stipend from the Massachusetts College of Pharmacy and Health Sciences, Boston MA, 02115 for students interning in the Office of the Chief Medical Examiner (OCME) upon approval of the Governor and Executive Council through June 30, 2019. 100% Agency Income.


EXPLANATION

The Massachusetts College of Pharmacy and Health Sciences pay a \$1,000 stipend per student who is able to participate in a one-month rotation at the OCME observing autopsies and learning about New Hampshire's death investigation system. Students are exposed to basic anatomy and physiology in a manner unmatched by any cadaver lab or computer simulated anatomic dissection. Students learn firsthand about the public health mission of the Medical Examiner's Office and broaden their education in clinical medicine making them more effective as health care providers. There is no cost to the State for providing this service to the students.

Based on need and current projections, these funds will supplement the budget in equipment in order to fund a laboratory grade specimen freezer.


