INFORMATIONAL ITEM

Pursuant to RSA 121:6-a "Report on Federal Landholdings", the Department of Natural and Cultural Resources respectfully submits a Report on Federal Landholdings (the Report). Additionally, pursuant to RSA 121:6 "Limitations on Right to Acquire", the Report addresses the following 2 thresholds:

1. Such (Federal) acquisition shall be limited in total within the State to 2% of the total land area; and
2. Such (Federal) acquisition shall be further limited in each town or city to an amount, the assessed value of which on April 1st of the preceding year, was 5% of the total assessed valuation on such date of all real estate in such town or city.

In accordance with RSA 121:6, the Report is based on federal lands acquired for the purpose of public conservation, forestry, recreation, experimentation or demonstration and does not include federal lands acquired by the White Mountain National Forest within the boundaries established by proclamation of the President of the United States, dated October 26, 1929.

Regarding threshold #2, many towns were not able to provide the historic assessment data required by law, therefore data highlighted in yellow is current data attained from the Department of Revenue Administration's state-wide database of tax maps and lots known as the "Mosaic."
