REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH on the basis of a low bid of \$5,308,013.40 for resurfacing approximately 13.5 miles along NH 28 from the date of Governor and Council approval through September 13, 2019 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2019 and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$265,400.67 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan under the 2019 Tier 2 Preservation Program. This project is resurfacing approximately 13.5 miles in length along NH 28. The project includes pavement resurfacing and guardrail replacement in Epsom, Chichester, Pittsfield, and Barnstead. The project limits start north of the Traffic Circle in Epsom (US 202/NH 9) and proceed northerly to a pavement joint approximately 900 feet north of Hillsgrove Road in Barnstead.

The primary focus of the project is the rehabilitation and resurfacing of the existing pavement along the project length, as well as improving safety. The work for this project involves spot travel way inlays, full width 1-1/2" overlays, and replacement of all guardrail and replacement of centerline rumble strips within the project limits.


The proposed contingency amount is 5% of the contract amount. This is to account for the risks associated with unanticipated traffic control needs, the variability of asphalt cost, and construction restrictions (due to high peak traffic during commuter hours).

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% federal funds with 20% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This project is part of the CY 2019 Tier 2 Resurfacing Program and is approximately 13.5 miles in length along NH 28. The project includes pavement resurfacing and guardrail replacement in Epsom, Chichester, Pittsfield, and Barnstead. The project limits start north of the Traffic Circle in Epsom (US 202/NH 9) and proceed northerly to a pavement joint approximately 900 feet north of Hillsgrove Road in Barnstead.

FEDERAL FUNDING: 80% utilizing Turnpike Toll credits as the State's 20% match

CONTINGENCY: The proposed contingency amount is 5% of the contract amount. This is to account for the risks associated with unanticipated traffic control needs, the variability of asphalt cost, and construction restrictions (due to high peak traffic during commuter hours).

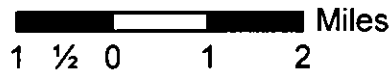
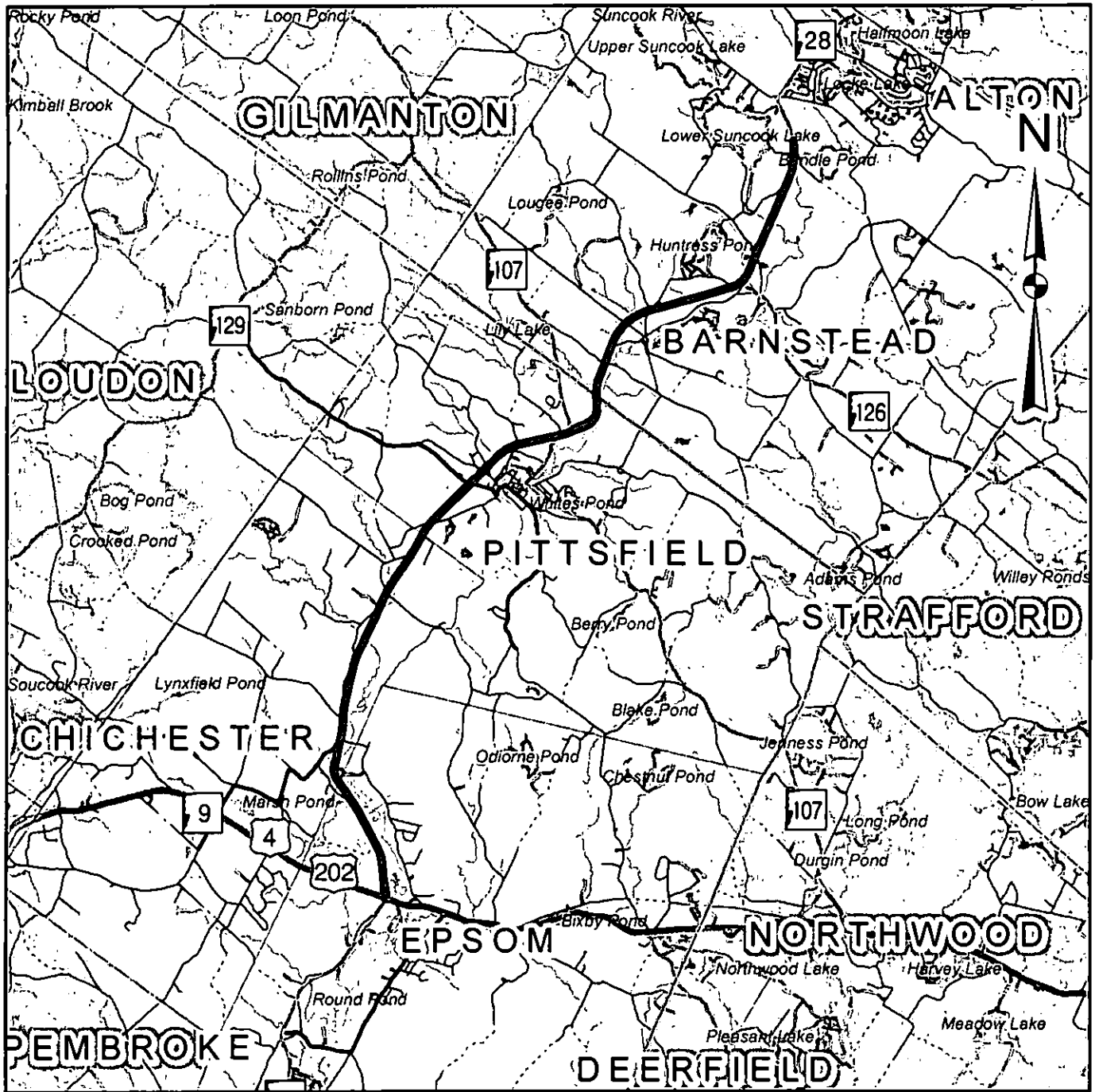
PROJECT INITIATED: This project is part of the CY 2019 Tier 2 Preservation Program.

PROJECT EXPLANATION: The primary focus of the project is the rehabilitation and resurfacing of the existing pavement along the project length, as well as improving safety. The work for this project involves spot travel way inlays, full width 1-1/2" overlays, and replacement of all guardrail within the project limits.

TRAFFIC IMPLICATION: This project will use one-lane, alternating two-way traffic, lane shifts and shoulder closures where necessary, supplemented with flaggers or uniformed officers with vehicle. Lane closures are not permitted during commuter hours (6:00-8:30am and 3:00-6:00pm) Monday through Friday. Additionally, work hours shall be modified at the discretion of the DCE during Holidays and special events.

EPSOM-BARNSTEAD - NH ROUTE 28

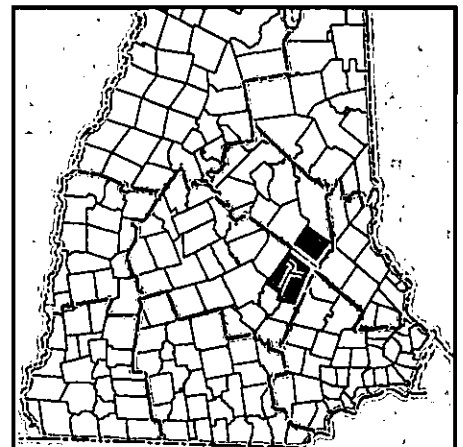
