The Department of Transportation requests placing this item on the Consent Calendar.

Pursuant to RSA 230:14, attached hereto is a Petition for a hearing on the proposed installation of an armoring layer (countermeasures) of material designed to resist erosion around the abutments and pier of the historic covered bridge carrying East Side Road over the Saco River (Br. No. 167/067). No building acquisitions will be required. However, temporary easements are required to allow construction access to the abutments and pier for this project.

Since the Petition is not for the limitation or control of access, a Commission of Three Persons should be appointed by the Governor, with the advice of the Executive Council, to hold a hearing. The Commission of Three shall determine whether there is occasion for the rehabilitation of the bridge as presented at the hearing.


To His Excellency, the Governor, and the Honorable Executive Council:
