REQUESTED ACTION

Authorize the Department of Transportation to enter into a contract with Skillings & Sons, Inc. of Amherst, NH (Vendor 161456) in the amount of \$20,515.00 for a 6-inch drilled well and pump on the property of Judi Lacroix, 1107 Concord Stage Road, (NH 77), Weare, NH, from the date of Governor and Council approval through June 30, 2021, unless extended by the Department in accordance with the Standard Specifications. 100% Highway funds.


