



Dr. Susan Lynch is a physician licensed by the State of New Hampshire. As Governor, John H. Lynch is eligible for participation in the New Hampshire Retirement System.

Governor John Lynch and Dr. Susan Lynch placed their assets (except as noted below) into three blind trusts (John H. Lynch Blind Trust, Susan E. Upton Lynch Blind Trust, and The Gould Hill Trust) in December 2004 and early January 2005. Under the terms of the legal contract creating the blind trusts, they will not receive any information about the specific investments of the trusts, or have any say in how the trusts' assets are invested. They receive quarterly reports only on the total value of the trusts, and they are subject to state interest and dividends taxes. Real estate subject to RSA 79-A was placed in trust.

Governor John Lynch also resigned as president of the J.H. Lynch Advisory Group, Inc. and placed the stock of the firm into his blind trust.

As he has done in previous public filings, Governor Lynch is also disclosing certain investments which exceeded 1% or more of the total outstanding stock of a business entity that were placed in the blind trusts. Under the terms of the blind trusts, Governor Lynch has no knowledge of whether these investments remain in the trust or not. The investments are:

- 1.) Knoll Inc.
- 2.) J.H. Lynch Advisory Group, Inc. (this business entity may be subject to state business taxes).

Governor Lynch is also disclosing investments he made through the J.H. Lynch Advisory Group, Inc. Under the terms of the blind trusts, Governor Lynch has no knowledge of the status of these investments.

- 1.) \$500,000 loan to Stone Sled Farm, LLC, which owned land on Wood Hill-Hooksett Road in Bow, NH.
- 2.) \$20,000 investment in Balanced View Communications, which owned WSNH, a radio station in Nashua.

On April 27, 2006, another trust under the name of The Gould Hill B Trust was established. It was established for the purpose of acquiring real property on Gould Hill in Hopkinton, and it acquired property on June 27, 2006.
