

The National Association of Surveillance and Utilization Review Officials (NASO) began in 1985 when a group of Medicaid Program Integrity officials met to discuss how they could improve communication and information sharing among the states. These officials determined a method of connecting professionals responsible for Medicaid surveillance and utilization review functions through a single organization. NASO. In 2006, NASO changed its name to NAMPI, to better reflect its mission. NAMPI's Mission Statement is: to support its members in their efforts to safeguard the fiscal, operational, and program integrity of their Medicaid programs; to enhance and or develop lines of communication between its members, other agencies and associations with similar goals; to expose its members to new techniques and technologies; to provide a mechanism for the dissemination of collective information to its members and the federal government; to promote the directions, ideals and accomplishments of the membership. NAMPI's Objectives are: to actively participate in monitoring trends in Medicaid policy that affect the utilization of Medicaid services; to act as a single body in the presentation of information to other associations, and federal and state agencies; to actively support member states by sharing information through a regularly published newsletter; to prepare and disseminate

an annual report of the membership's accomplishments; to encourage all states to participate in the membership of the organization; to enhance membership participation in the organizationally sponsored annual conference; to create an atmosphere through membership that provides the opportunity to have connectivity and promote synergy.
