

Good Afternoon, Senator Larsen!

We are pleased to invite you to participate in a National Conference of State Legislatures (NCSL) roundtable discussion entitled, "2013 Child Welfare Fiscal Policy Leadership Roundtable: Better Results for Kids." The meeting will be held at NCSL's Legislative Summit in Atlanta, Georgia, on Monday, August 12, 2013 from 8:00 a.m. – 1:30 p.m. NCSL will cover up to \$800 for the cost of travel, plus meals and hotel accommodations in conjunction with attending the session.

**OVERVIEW.** We are reaching out to experienced leaders of fiscal or appropriations subcommittees and leaders of human services or children and families committees, such as yourself, from a small group of states to engage in a small-group roundtable and interactive dialogue about child welfare financing, the need for finance reform, and how funding decisions are made for children in, or at risk of entering, the child welfare system. Discussion will also cover the barriers to reform, lessons learned from other states and successful strategies that states can use. These strategies include reinvesting savings from foster care caseload reductions into prevention services, use of block grants and prevention funding, performance-based contracting and Title IV-E child welfare demonstration waivers. Specific state examples and strategies will be examined. The agenda will allow plenty of time for discussion and provide an opportunity for legislators and legislative staff to meet with their colleagues from other states as they consider how to better align child welfare financing with desired outcomes for children and families.

If you are able to attend, we will be contacting you to help you prepare for the discussions that will be held at the meeting. **We ask that you come prepared to talk about child welfare financing issues in your state, including challenges, barriers, and solutions.**

**EXPENSES.** NCSL will reimburse legislators for their hotel stay on Sunday, August 11th, 2013, and meals during travel and those not provided on the meeting day (up to \$75 per day with

itemized receipts). There is no registration fee for the roundtable. Attendees must make the commitment to attend the entire program on August 12. Participants will pay all expenses up front and will be reimbursed *after* the meeting. If legislators attending the roundtable wish to stay and participate in NCSL's Legislative Summit, they can register and pay a discounted rate of \$549.00 for the Summit.

**SPONSORSHIP.** The Child Welfare Project, within the Children and Families Program at NCSL, is sponsoring this program in partnership with Casey Family Programs.


