Article IV

Purposes: The Fund is dedicated to the protection, preservation, and furtherance of the retail energy markets and to the strengthening of the retail energy markets for the purposes of fostering an economic environment in which the Company and can flourish and prosper. To achieve these purposes, the Fund is empowered to solicit and accept voluntary contributions from individuals and to expend such contributions to support the nomination for election, and the election, of candidates for federal elective public office who it is believed are in general agreement with any purpose of the Fund. In carrying out the foregoing, the Fund is empowered to make contributions, within legal limits, to the candidates and/or the campaign committee of candidates or political parties. The Fund is not, however, to be affiliated with any political party. The Fund will not engage in any other activity whatsoever, and, in particular, will not influence, or attempt to influence, legislative or administrative actions.
