
Enclosed please find the October 27, 2004, Report for McKim Mitchell, who is a candidate for Senate District #10.

It has come to my attention that the report I filed on October 13, 2004, may have been misleading regarding the "Aggregate" column in the report. In that report, I reported the total campaign aggregate (i.e. primary and general election) for each contributor rather than only the aggregate general election contributions. Because the October 13, 2004, submission was the first report after the Primary, every contribution listed is a General Election contribution and there are no General Election aggregates to report, except for Robert P. Hubbard, of Bluestone Hill, Walpole, New Hampshire. Mr. Hubbard's \$500 contribution of July 7, 2004, was applied to the General Election receipts and so Mr. Hubbard's aggregate for the General Election is \$1000.

In this October 27, 2004, report, I only report campaign aggregate amounts for the General Election.
