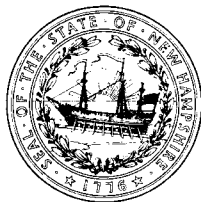

EXPLANATION


