REQUESTED ACTION

EXPLANATION

The above-mentioned subgrant recipients have been awarded previous Justice Department Victims Funds (JDVF) awards from this office. Your approval will allow the above-funded organizations to continue providing the vital services that New Hampshire's citizens have come to rely upon.

Seven of the above programs support a victim advocate position at county attorneys' offices. Victim advocates provide a wealth of services, including educating victims about the criminal justice system and assisting them through the process. Advocates also accompany the victim to court hearings, provide assistance with victim impact statements, and refer victims to other local services.

The eighth subgrant will support one supervised visitation center in Jaffrey, New Hampshire. This center provides a neutral environment for non-residential parents to visit their children. The majority of visitation clients are court ordered to use supervised visitation centers when there is a history of family violence.
