REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract amendment, (Contract # 4011875, Project # 43031) with Pike Industries, Inc., (Vendor # 177300), of Belmont, N.H., by increasing the contract amount by \$290,000.00, (from \$6,175,808.13 to \$6,465,808.13) for pavement rehabilitation and preservation on 14 miles of NH Rte. 101 in Milford and Amherst effective upon Governor and Council approval through September 9, 2022 unless extended by the Department in accordance with the Standard Specifications. 100 % Federal Funds.

Funding is available in State Fiscal Year 2022 and Fiscal Year 2023 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:


EXPLANATION

The Milford-Amherst X-A005(016), 43031 contract was approved by Governor and Council on June 2, 2021 (Item # 38) on a basis of a low bid for an original contract encumbrance of \$6,175,808.13. The contract is proposed to be increased by \$290,000.00 to address the following items:

1. In accordance with the contract terms, additional price adjustment for liquid asphalt cement and fuel will be required due to the price escalation of oil. Estimated Cost \$255,000.00.
2. Unanticipated costs are required to transition the existing guard rail to the new guard rail end sections in order to adhere to current safety standards. Estimated Cost is \$35,000.00.

REQUESTED ACTION

Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. of Belmont, NH (Vendor 177300), on the basis of a low bid of \$6,175,808.13, for pavement rehabilitation and preservation on 14 miles of NH 101 in Milford and Amherst, from the date of Governor and Council approval through September 9, 2022, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2021, and is contingent upon the availability and continued appropriation of funds in Fiscal Years 2022 and 2023 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan. This project consists of pavement rehabilitation and preservation on three (3) sections of NH 101 in Milford and Amherst, totaling 14.4 centerline miles.

- 22501A – Milford, NH 101, 7½” full-width inlay: 6” HBP Binder in two equal lifts, 1½” HS HBP, 0.4 miles
- 22502 – Milford-Amherst, NH 101 including acceleration and deceleration areas, 2” full-width overlay: ½” leveling course, 1½” HS HBP (10.1 miles), 3” full-width inlay: 1½” HS Binder, 1½” HS HBP (0.1 miles), 10.2 miles
- 22502A – Milford-Amherst, NH 101 including all NH 13, NH 101A, NH 122 (S), and NH 122 (N) Ramps, Spot Inlays: 2 miles of 2” deep by 13’ wide, NH 13 Ramps: 2” full-width overlay: ½” leveling course, 1½” HS HBP (1.0 mile) NH 101A Ramps: 1¼” HS HBP full-width overlay (1.3 mile), NH 122 (S) & NH 122 (N) Ramps: ¾” Paver Shim full-width overlay (1.5 miles), 3.8 miles

This project is part of the CY 2021 Federal Tier 2 Resurfacing Program. Mainline NH 101 will be deep milled and filled with Binder and High Strength (HS) wearing course (Section 22501A) and resurfaced via leveling and HS wearing course (Section 22502). The ramps (Section 22502A) will be resurfaced via

leveling and HS wearing course (NH 13 ramps), HS wearing course (NH 101A ramps), and paver shim (NH 122 south and north ramps). Additional work includes 7,369' of guardrail upgrades, centerline rumble strip reinstallation, relaying 16' of 48" RCP, drainage structure adjustments, and sign replacement.

Although the bid costs exceeded the Department's estimate by 3.18%, the low bid of three bids received is felt to be reasonable for the work involved. Three items of significance (Maintenance of Traffic, Mobilization, and HBC Leveling Course) contributed to 100% of the overage. Re-advertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.


The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 80% Federal (Pave-T1-Resurf), with anticipated utilization of Turnpike Toll Credits for the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

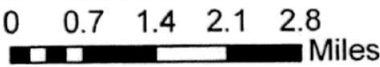
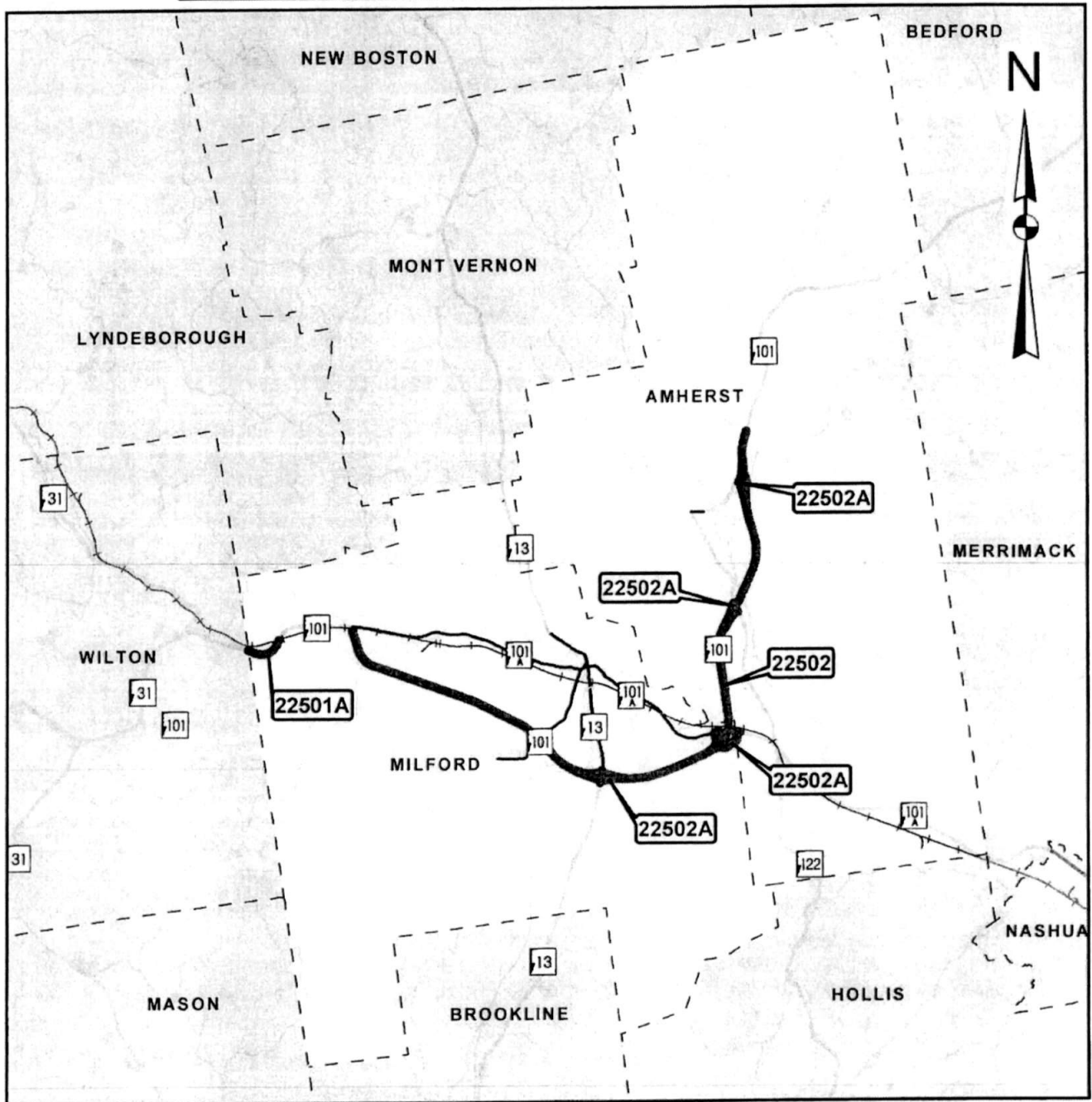
PROJECT EXPLANATION: This project is part of the CY 2021 Federal Tier 2 Resurfacing Program. Mainline NH 101 will be deep milled and filled with Binder and HS wearing course (Section 22501A) and resurfaced via leveling and HS wearing course (Section 22502). The ramps (Section 22502A) will be resurfaced via leveling and HS wearing course (NH 13 ramps), HS wearing course (NH 101A ramps), and paver shim (NH 122 south and north ramps). Additional work includes 7,369' of guardrail upgrades, centerline rumble strip reinstatement, relaying 16' of 48" RCP, drainage structure adjustments, and sign replacement. All impacted towns and utilities will be notified of the work.

TRAFFIC IMPLICATION: **Section 22501A**, NH 101: All work will be night work. One-lane, alternating two-way traffic will be required in order to complete the work. A 16-foot minimum lane width will be maintained at all times when travel is limited to one lane on NH 101. **Section 22502**, NH 101: All work will be night work. This crosses an urban compact; the Town of Amherst will be notified. Ponemah Rd/NH 122 and NH 101A will be utilized during the NH 122 (south) WB On ramp closure. NH 13 and NH 101A will be utilized during the NH 13 EB On ramp closure. Traffic will be restored to normal patterns at the end of each workday. Work zone significance was determined to be non-significant at the July 16, 2020 TCC Meeting.

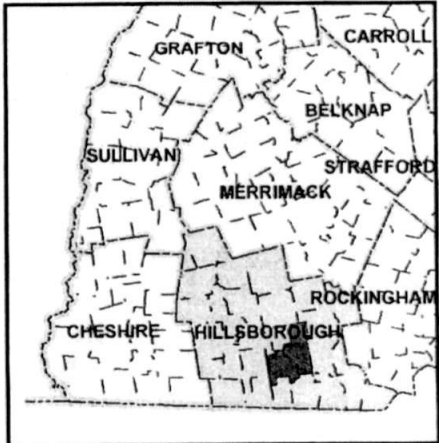
