#### **REQUESTED ACTION**

Authorize the Department of Justice (DOJ) to enter into a subgrant with the Town of Lincoln, NH (Vendor #177424-B001), in an amount not to exceed \$26,098, from the American Rescue Plan Act (ARPA), to support municipalities and state agencies with activities related to relaxed COVID-19 restrictions, effective upon Governor and Executive Council through June 30, 2023. 100% Federal Funds.

Funding is available as follows:

#### EXPLANATION

Due to relaxed COVID-19 rules and restrictions and increased post-pandemic demand for travel, hospitality, tourism, and other services, it is expected that the State of New Hampshire will see a heavy influx of resident and tourist activity. This increase poses a challenge to state agencies and municipalities managing large groups of tourists and crowds at events.

The Town of Lincoln will utilize funds to better address an increase in tourism and traffic that has impacted the area. Since the pandemic, tourism has risen substantially in Franconia Notch, the White Mountains National Forest, the Appalachian Trail, and other destination locations in the Town of Lincoln. Funds will be used to purchase speed signs and a message board in order to communicate safety information and important messages to the public. The new signs will provide tourists and the local community with vital information meant to keep people safe and aware of traffic laws.

The State, and anyone it shall designate, shall have unrestricted authority to publish, disclose, distribute and otherwise use, in whole or in part, all data.

- CONDITIONAL NATURE OR AGREEMENT. Treat the agreement as breached and pursue any of its remedies at law or in equity, or both

#### TERMINATION,

In the event of any early termination of this Agreement for any reason other than the completion of the Project; the Granice shall deliver to the Grant Officer, not later than fifteen (15) days after the date of termination, a report (hereinafter referred to as the "Termination Report") describing in detail all Project Work performed, and the Grant Amount earned, to and including the date of termination. in the event of Termination under paragraphs 10 or 12.4 of these general provisions, the approval of such a Termination Report by the State shall entitle the Granice to receive that portion of the Grant amount earned to and including

the date of termination? In they event of Termination under paragraphs 10 or 12.4 of these general provisions, the approval of such a Termination Report by the State shall in no event relieve the Granice from any and all liability for damages sustained or incurred by the State as a result of the Grantee's breach of its obligations hercunder:

Notwithstanding anything in this Agreement to the contrary, either the State or, except where notice default has been given to the Grantee hereunder, the Grantee, may terminate this Agreement without cause upon thirty (30) days written notice. CONFLICT OF INTEREST. No officer, member of employee of the Grantee, and no representative, officer or employee of the State of New Hampshire or of the governing body of the locality or localities in which the Project is to be performed, who exercises any functions or responsibilities in the review or

# EXHIBIT A

### Scope Of Services

- 1. The Town of Lincoln as the Grantee (hereinafter referred to as "Subrecipient") shall be compliant at all times with the terms, conditions and specifications detailed below, which are subject to annual review.
- 2. The Subrecipient must certify that Limited English Proficiency persons have meaningful access to any services provided by this program. National origin discrimination includes discrimination on the basis of limited English proficiency (LEP). Meaningful access may entail providing language assistance services, including oral and written translation when necessary. The U.S. Department of Justice has issued guidance for grantees to help them comply with these requirements. The guidance document can be accessed on the Internet at www.lep.gov.
- 3. The Subrecipient assures that in the event a Federal or State court or Federal or State administrative agency makes a finding of discrimination within the three years prior to the receipt of the federal financial assistance and after a due process hearing against the Subrecipient on the grounds of race, color, religion, national origin, sex, age, or disability, a copy of the finding will be submitted to the New Hampshire Department of Justice, Grants Management Unit and to the US: Department of Justice, Office for Civil Rights, Office of Justice Programs, 810 7th Street, NW, Washington, D.C. 20531. - 4. The Subrecipient will comply (and will require any subrecipients or contractors to comply) with any applicable nondiscrimination provisions, which may include the Omnibus Crime Control and Safe Streets Act of 1968 (34 U.S.C. § 10228(c)); the Victims of Crime Act (34 U.S.C. § 20110(e)); the Juvenile Justice and Delinquency Prevention Act of 2002 (34 U.S.C. § 11182(b)); the Violence Against Women Act (34 U.S.C. § 12291(b)(13)); the Civil Rights Act of 1964 (42 U.S.C. § 2000d); the Indian Civil Rights Act (25 U.S.C. §§ 1301-1303); the Rehabilitation Act of 1973 (29 U.S.C. § 794); the Americans with Disabilities Act of 1990 (42 U.S.C. §§ 12131-34); the Education Amendments of 1972 (20 U.S.C. §§ 1681, 1683, 1685-86); and the Age Discrimination Act of 1975 (42 U.S.C. §§ 6101-07). It will also comply with Ex. Order 13279, Equal Protection of the Laws for Faith-Based and Community Organizations; Executive Order 13559, Fundamental Principles and Policymaking Criteria for
- 5. Partnerships With Faith-Based and Other Neighborhood Organizations; and the DOJ implementing regulations at 28 C.F.R. Part 38.
- 6. Compensation for individual consultant services is to be reasonable and consistent with that paid for similar services in the marketplace. The current consultant limit is \$650 per day or \$81.25 per hour. When the rate exceeds the limit for an 8-hour day, or a proportionate hourly rate (excluding travel

and subsistence costs), a written prior approval is required. Prior approval requests require additional justification.

- 7. The Subrecipient agency agrees that, should they employ a former member of the NH Department of Justice (NHDOJ), that employee or their relative shall not perform work on or be billed to any federal or state subgrant or monetary award that the employee directly managed or supervised while at the NHDOJ for the life of the subgrant without the express approval of the NH DOJ.
- 8. The Subrecipient understands that grants are funded for the grant award period noted on the grant award document. No guarantee is given or implied of subsequent funding in future years.
- 9. The Town Lincoln as Subrecipient shall receive a grant from the New Hampshire Department of Justice (DOJ) for expenses incurred for activities related to responding to relaxed COVID-19 restrictions, specifically state agencies and municipalities in managing large groups of people and dealing with increases in tourist and other activities that may lead to unrest or other security challenges. Subgrants may include, but not be limited to, paying for safety items, funding overtime for local police departments, and increasing personnel resources.
- 10. All activities must occur and expenses must be incurred by the completion date of the grant specified in Paragraph 1.7
- 11. Subrecipient agrees and covenants that the funds will be used solely for an allowable purpose as defined in in the American Rescue Plan Act for which Subrecipient has not received payment or reimbursement from any other source, defined as:
  - For the provision of government services to the extent of the reduction in revenue due to the COVID- 19 public health emergency relative to revenues collected in the most recent full fiscal year prior to the emergency
- 12. The Subrecipient shall be reimbursed by the DOJ based on budgeted expenditures described in Exhibit B. The Subrecipient shall submit incurred expenses for reimbursement on the state approved expenditure reporting form as provided. Expenditure reports shall be submitted on a quarterly basis, within fifteen (15) days following the end of the current quarterly activities. Expenditure reports submitted later than thirty (30) days following the end of the quarter will be considered late and out of compliance. For example, with an award that begins on January 1, the first quarterly report is due on April 15<sup>th</sup> or 15 days after the close of the first quarter ending on March 31.
- 13. Subrecipient is required to maintain supporting documentation for all grant expenses both state funds and match if provided and to produce those documents upon request of this office or any other state or federal audit authority. Grant project supporting documentation should be maintained for at least 5 years after the close of the project.

- 14. Subrecipient shall be subject to periodic desk audits and program reviews by DOJ. Such desk audits and program reviews shall be scheduled with Subrecipient and every attempt shall be made by Subrecipient to accommodate the schedule.

# Emergency Operation Center (EOC) Grant:

Representative Annie Kuster has selected the Town of Lincoln's application for the construction of a new Safety Services Building project and will now move on to the House Appropriations Committee for further consideration. Each Representative may request funding for up to 15 projects in their community, for fiscal year 2023 (a handful of these projects may actually be funded).

#### NH DOT Scenic Byways Grant Program:

DOT is requesting additional application information and has extended the deadline to May-20<sup>th</sup> for submission.

### NH DOT, Paving:

DOT will begin resurfacing pavement between. Lincoln (Mile Marker 105.9) and Franconia Notch (north/south bound). Road work will be performed during the evening hours between 6pm and 6am, Sunday through Friday.

# North Country Council (NCC) - 10-Year Transportation Plan:

North Country Council is soliciting projects to be included in their 10-year Transportation Plan. Projects include the following categories. Highway Improvement, Asset Management, Bike/Pedestrian Improvements, Planning Study & Infrastructure related Travel Demand Management. Carina suggested putting in for a corridor management study for Route 112 (NCC is looking for communities with traffic data collection needs). Selectman Ham commented that she is not opposed to a traffic study, however, they need to tread lightly on this matter because the State could potentially make Rt. 112 a four (4) lane roadway which would eliminate all parking on Main Street: 化原始合理 网络普美

Paul Beaudin commented that the Town should try to get ahead of this situation in light of the continued growth in town (Hotels, South Peak development etc.), and now may be the right time to begin looking at traffic studies which would be beneficial for future development. #### Loon Mountain Parking Request:

Loon Mountain has requested the use of the Kanc Rec parking lot; Mansion Hill field, Community Center, and Industrial Business Park parking areas (Saturday & Sunday only) for additional parking during the Highland Games weekend (Sept. 16-18). NH Scots and Loon Mountain will be providing porta-potties, parking attendants and/or signage, and ensure all areas are cleared of trash. Robinson noted that the town has loam and others materials stored at the Mansion Hill field and these items won't be moved, but Loon is welcome to use these requested areas for parking.

#### Hanson Farm Road Fence:

Carina spoke with DPW Hadaway about the fencing on Hanson Farm Road. The fence was removed for the reconstruction of Hanson Farm Road. Nate explained that during the Hanson Farm Road Repair Project (2016), Town Manager Burbank had made an agreement to compensate the property owner for their share of the fencing that was *not* installed. The Town was unaware that the original site plan approval for this property required a fence along Hanson Farm Road. If the Town now builds a new fence, we would essentially be paying this property owner twice (the Board was not aware of this financial compensation). Robinson suggested that going forward Director Hadaway have a friendly discussion with the property owner to cooperatively come to a resolution.

#### One Love Brewery – Use of Memorial Park Gazebo:

One Love Brewery submitted a Special Event Application (see attached) for Memorial Day weekend; and is requesting the use of the Town's Gazebo on Saturday, May 28<sup>th</sup> for live music from 3pm-6pm. Chief Morris has expressed some concerns with open containers in the green, and is looking for further guidance from the Board. Selectman Daly suggested that one of the conditions for the permit approval is that One Love Brewery hire Police detail for this event. Selectman Ham would like to hear Chief Morris's concerns and recommendations for the event prior to making a motion to approve this application. The Board agreed to have Carina approve the permit if Chief Morris's concerns are all addressed.



#### CERTIFICATE OF COVERAGE

The New Hampshire Public Risk Management Exchange (Primex<sup>3</sup>) is organized under the New Hampshire Revised Statutes Annotated, Chapter 5-B, Pooled Risk Management Programs. In accordance with those statutes, its Trust Agreement and bylaws, Primex<sup>3</sup> is authorized to provide pooled risk management programs established for the benefit of political subdivisions in the State of New Hampshire.

Each member of Primex<sup>3</sup> is entitled to the categories of coverage set forth below. In addition, Primex<sup>3</sup> may extend the same coverage to non-members. However, any coverage extended to a non-member is subject to all of the terms, conditions, exclusions, amendments, indes, policies, and procedures that are applicable to the members of Primex<sup>3</sup>, including but not limited to the final and binding resolution of all claims and coverage disputes before the Primex<sup>3</sup> Board of Trustees. The Additional Covered Party's per occurrence limit shall be deemed included in the Member's per occurrence limit, and therefore shall reduce the Member's limit of liability as set forth by the Coverage bocuments and Declarations. The limit shown may have been reduced by claims paid on behalf of the members. General Liability coverage is limited to Coverage A (Personal Injury Liability) and Coverage B (Property Damage Liability) only, Coverage's C (Public Officials Errors and Omissions), D (Unfair Emptoyment Practices), E (Employee Benefit Liability) and F (Educator's Legal Liability Claims-Made Coverage) are excluded from this provision of coverage.
