

The rapid growth of natural gas and renewable energy, combined with new approaches to manage fluctuations in demand and production, are creating structural shifts in regional and state electricity markets. This upending market dynamic is raising questions regarding the reliability of energy sources, what this means for jobs and state economies and the risk implications to the nation's critical energy infrastructure. This meeting will explore how electricity markets function, how these changes affect states in restructured and vertically integrated markets and how states are adapting to these changes. It will also discuss how new energy management technologies, such as energy storage and demand response, are dramatically influencing how the grid is managed.

The threatened loss of these traditional baseload resources has raised concern among some stakeholders, spawning a variety of state, regional and federal efforts that would provide market supports, as has occurred for other electricity resources.
