REQUESTED ACTION

EXPLANATION

The purpose of this request is to budget funds received from the Clean Cities Coalition Cooperative Agreement (GSCCC). GSCCC is a program funded through a grant from the U.S. Department of Energy, and coordinated by the Air Resources Division. The Coalition works with over 150 stakeholders, representing public and private vehicle fleets, businesses, and municipalities, to reduce petroleum consumption from the transportation sector. This is accomplished through outreach, education, and support for projects implementing low- and zero-emissions fuels and vehicles, and fuel-efficiency strategies. Planned staff time work for fiscal years 2020 and 2021 was delayed by the pandemic. This additional funding will allow NHDES to meet these project accomplishments timely.
