1). Authorize the Division of Public Works Design and Construction to enter into a contract with D. L. King & Associates Inc., (VC# 168979) Nashua, NH, for a total price not to exceed \$713,685, for the Elevator Upgrade at New Hampshire State Men's Prison, Concord, NH. EXPLANATION

Per Chapter 228:1, IV, C, Laws of 2017, for the Elevator Replacement at the New Hampshire Men's State Prison, Concord, New Hampshire. This project will replace the elevator for the Secure Psychiatric Unit, Close Custody Unit, and Maintenance areas that breaks on a regular basis trapping inmates and staff. This elevator is also used to transport food, medical, and maintenance carts daily. The second elevator serves the Health Service/Infirmary, Parole Board, and Control Point 5, the main entry point for staff; this elevator also breaks down frequently. Upgrades are essential as the Department relies on these elevators being in service without interruption.

The contractor has been pre-qualified by the Department of Transportation. The contract has been approved by the Department of Justice as to form and execution, and the Department of Corrections has certified that the necessary funds are available. 
