REQUESTED ACTION

The Department of Cultural Resources, Division of Historical Resources, respectfully requests permission to award a Conservation Number Plate Grant to Friends of Stark Park, Manchester (vendor #229767) in the amount of \$10,000.00 upon Governor and Council approval through November 30, 2014. Other funds are available in 01-34-34-340010-6999000-054-500527

EXPLANATION

Pursuant to RSA 261:97- c Conservation Number Plate Funds shall be used to promote the use and conservation of cultural resources in New Hampshire and to preserve the cultural heritage that belongs to all New Hampshire citizens by providing for the conservation and preservation of significant publicly-owned works of art, artifacts, and documents that contribute to New Hampshire's cultural heritage. This shall include historic sculptures.

The burial site of New Hampshire's most famous soldier, General John Stark, is located in Stark Park in Manchester and is owned by the City. Over time the site has deteriorated and the concrete curbing and piers around the grave are in need of repair. The Friends of Stark Park will oversee the repair of this gravesite. Contractors specializing in concrete will be hired to repair the cracked and deteriorated piers and curb. The Conservation License Plate grant will be part of this project that will also use other grants, donations and in-kind services to complete this project.

GRANT AGREEMENT **Grant #MP-12-04**

New Hampshire Division of Historical Resources

This agreement between the State of New Hampshire, Division of Historical Resources (hereinafter "DHR") and Friends of Stark Park, Inc. (hereinafter "Grantee") is to witness receipt of funds subject to the following conditions:

- 1. GRANT PERIOD: November 30, 2012 - November 30, 2014
- OBLIGATION OF THE GRANTEE: The Grantee agrees to accept \$10,000. and apply it to the project(s) described in the grant application and approved budget referenced above. In the performance of this grant agreement the Grantee is in all respects an independent contractor and is neither an agent nor employee of the State.

As required by the Conservation License Plate Grant Program and the DHR, Grantee agrees to prominently place a DHR provided grant information sign on site or within the community throughout the project funded by this grant, and to acknowledge support of the DHR and the Conservation License Plate Program on any materials promoting the project.

The Grantee agrees to abide by the limitations, conditions and procedure outlined herein and in the attached appendices. If appropriated funds for this grants program are reduced or terminated, all payments under this grant shall cease.

- PAYMENT of 50% will be made following review by the NH Attorney General's Office and Governor and Council. Payment of the final 50% will be made upon receipt and approval of the final report documentation.
- FINAL REPORT: The Grantee agrees to submit a narrative report of progress at the six month point in the grant period. The Grantee agrees to submit a final financial and project report in a format provided by the DHR, no more than 30 days after the end of the grant period.
- SOVERIGN IMMUNITY: No provision of this contract is to be deemed a waiver of sovereign immunity by the State of New Hampshire.


