REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint Geoffrey W. R. Ward, Position #9U054 (Appropriation #02-20-200510-2610-013-500132), as an Assistant Attorney General at a salary level of \$112,000, effective upon Governor and Executive Council approval, or August 20, 2022, whichever is later, for a term ending August 20, 2027.

EXPLANATION

Mr. Ward, a Durham resident, received his Bachelor of Arts from Colby College in 2002, and his Juris Doctor from Franklin Pierce Law Center (now University of New Hampshire School of Law) in 2007. In law school, he was a Teaching Assistant in Criminal Law (2006), Regional Finalist in the National Trial Competition (2007), and Nedved Award recipient for most outstanding Advanced Trial Advocacy advocate in the class (2007). Following his 2007 admission to the New Hampshire Bar, he served five years as an Assistant County Attorney in Rockingham County. From 2011 to 2013, he also served as an Adjunct Professor at University of New Hampshire School of Law where he taught Advanced Trial Advocacy. Mr. Ward joined the Department in 2012 and was assigned to the Criminal Justice Bureau. He was commissioned as an Assistant Attorney General in 2013, designated Senior Assistant Attorney General in 2017; and named Criminal Justice Bureau Chief in 2018. This reappointment will give him a full five-year term. He will continue serving in his current assignment and his salary will remain the same. His resume is attached.

RSA 94:1-a(I)(c)(3) provides that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
