REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Northeast Earth Mechanics, LLC (Vendor 156610) of Pittsfield, NH, on the basis of a single bid of \$344,700.00 for rehabilitation of a corrugated metal arch culvert carrying Beards Creek under Madbury Road in Madbury (Project: Madbury 43276), from the date of Governor and Council approval through October 28, 2022, unless amended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Years 2022 and 2023, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

EXPLANATION

This project is part of the State's Ten-Year Transportation Improvement Plan, under the Culvert Replacement/Rehabilitation and Drainage Repair (CRDR) Program. The project will rehabilitate an existing 58" wide x 36" high x 131' long corrugated metal arch culvert carrying Beards Creek under Madbury Road located approximately one-half mile north of US 4. The proposed rehabilitation will remove approximately 7' of the existing culvert at the inlet, construct a concrete headwall, and slipline the remaining portion of the existing pipe with a polymer coated corrugated metal arch pipe liner. Incidental work includes repair of sinkholes on the inlet and outlet side embankment slopes and matching the existing stream channel to the new headwall at the inlet.

The existing culvert is a 58" x 36" x 131' long corrugated metal arch pipe carrying Beards Creek under Madbury Road. The culvert was originally constructed in 1980 and is in poor condition with heavy rust,

some perforations, and a dent in the lower side of the inlet edge. Sections of missing invert have caused sinkholes and loss of backfill around the culvert ends. The proposed rehabilitation will maintain the hydraulic capacity of the crossing.

The proposed contingency amount is 10% of the contract amount. This is to account for the risks associated with the unknown extent of voids and sinkholes around the existing pipe, unanticipated traffic control needs, and potential risk of over-runs in minor Items such as erosion control.

Although the bid costs exceeded the Department's estimate by 46.34%, the sole bid received is felt to be reasonable for the work involved. There was one item of significance which accounted for 100% of the overage (Polymer Coated Corr.Galv. Steel Liner for Arch Pipe). Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. Putting off the work would lead to more expensive repairs or replacement. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 80% Federal (Culvert Replacement/Rehabilitation and Drainage Repair (CRDR) Program), with anticipated utilization of Turnpike Toll credits as the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.




