## REQUESTED ACTION

- 1. Pursuant to the provisions of RSA 14:30-a, VI, Additional Revenues, authorize the Department of Health and Human Services, Division of Economic and Housing Stability to retroactively amend Fiscal Item #18-195, approved by the Fiscal Committee on October 19, 2018 and Item #16 approved by Governor and Executive Council on October 31, 2018 by extending the authority to expend federal funds in the amount of \$1,130,113 from the Child Care Development fund program effective upon approval by the Fiscal Committee and Governor and Executive Council from June 30, 2019 through September 30, 2019, and further authorize the allocation of these funds in the accounts below. 100% Federal Funds.
- Pursuant to RSA 124:15 and contingent upon approval of Requested Action #1, authorize the Department of Health and Human Services to establish Class 046 – Consultants for the purpose of developing a NH Child Care Information System effective upon Fiscal Committee and Governor and Council approval through September 30, 2019. 100% Federal Funds.

#### **EXPLANATION**

This retroactive item requests to extend spending authority from June 30, 2019 to September 30, 2019 of funds accepted in FY19 and unspent at the end of the fiscal year. This request makes the additional grant funds accepted in SFY 2019 available for SFY 2020 to administer the Child Care Development Fund Program under Title IV-A of the Social Security Act, as amended by Title VI of the Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) 1996, P.L. 104-193, effective October 1, 1996. These funds are discretionary, with no General Funds match required. The notice of additional funds awarded was received in August 2018.

These funds will be used to expand upon the existing MTX contract for the design, implementation, and support of an information system for the New Hampshire Department of Health and Human Services (DHHS) Bureau of Child Development and Head Start Collaboration (BCDHSC) and the Child Care Licensing Unit (CCLU). These entities are collaborating to build a NH Child Care Information System to replace the existing Child Care Aware of America NDS system for child care that will no longer be available within the next few years. It shall also replace the existing background check system that has been found to be out of compliance with federal requirements.

Funds are being budgeted in Class 038 (Technology-Software) for software licenses. Funds are being budgeted in Class 046 (Consultants) for Information Technology vendor services. The answers to the memo dated September 21, 1981 related to creating a position or consultant are provided on page 4. Funds are being budgeted for Audit costs (Class 041) per state requirements.

Listed below are answers to standard questions required of all Fiscal Committee item requests, related to RSA 14:30-a, VI "Expenditure of funds over \$100,000 from any Non State Source", or RSA 124:15,"Positions Authorized" or both and All Emergency requests:

- 1. Is the action required of this request a result of the Continuing Resolution for FY 2020?
  - No, this action is not a result of the Continuing Resolution. These funds were initially appropriated in SFY19 but were not spent by the end of the SFY and are available to accept in FY 2020.
- 2. If this request is **retroactive** what is the significance and importance of the action being effective from an earlier date?
  - This item requests authority to extend spending authority from June 30, 2019 to September 30, 2019 of funds accepted in FY19 and unspent at the end of the fiscal year which will be used to expand upon the existing MTX contract for the design, implementation, and support of an information system for the New Hampshire Department of Health and Human Services (DHHS) Bureau of Child Development and Head Start Collaboration (BCDHSC) and the Child Care Licensing Unit (CCLU).
- 3. Is this a previously funded and ongoing program established through Fiscal Committee and Governor and Executive Council action? (If so, include as an attachment the original documents as approved and cite the specific dates of authorization and end dates for each action as part of your answer to this question.)

Yes, this was previously funded and is an ongoing program established through Fiscal Committee and Governor and Executive Council action. The item was previously approved by the Fiscal Committee on October 19, 2018, FIS 18-195 and by Governor and Executive Council on October 31, 2018, Item #16, both effective through June 30, 2019.

4. Was funding for this program included in the FY 2018-2019 enacted Budget or requested and denied?
The funding for this program was included in the FY 2018 – FY 2019 enacted budget.

5. Is this program in total or in part, included in the vetoed FY 2020-2021 Operating Budget proposal currently pending for your department, or was it requested and denied?

Yes, this program is included in the vetoed FY 2020-2021 Operating Budget however this request is for funding in excess of the funds budgeted in FY 2020-2021.

6. Does this program include, either positions or consultants, and if so are the positions filled, vacant, or have offers pending? (Please provide details for each position and note whether consultant contracts have been awarded.)

There are currently no positions or consultants funded in this program; however, this item creates Class 046 (Consultants) which will be used for Information Technology vendor services.

7. What would be the effect should this program be discontinued or not initiated as a result of this request being denied?

By not approving this request, the Department could potentially be out of compliance with the requirements of the Child Care and Development Block Grant Act, signed into law on November 19, 2014. A requirement of the CCDF Federal Plan mandates spending up to 12% of the CCDF funds on quality activities, of which 3% must focus on infant/toddler activities.

In the event that these Federal Funds become no longer available, General Funds will not be requested to support this program.

- 1. List of personnel involved: Temporary consultants
- 2. Nature, Need, and Duration: The temporary consultants will provide for the increased needs for subject matter experts beyond the limited resources of in-house personnel. These funds will be encumbered pursuant to a contract amendment that will be presented to Governor and Council on September 18, 2019.
- 3. Relationship to existing agency programs: The consultants will develop a NH Child Care Information System to replace the existing Child Care Aware of America NDS system for child care that will no longer be available within the next few years. It shall also replace the existing background check system that has been found to be out of compliance with federal requirements.
- 4. Has a similar program been requested of the legislature and denied? No
- 5. Why wasn't funding included in the agency's budget request? This was previously funded and is an ongoing program established through Fiscal Committee and Governor and Executive Council action. The item was previously approved by the Fiscal Committee on October 19, 2018, FIS 18-195 and by Governor and Executive Council on October 31, 2018, Item #16, both effective through June 30, 2019.
- 6. Can portions of the grant funds be utilized? All grant dollars are being used for this request.
- 7. Estimate the funds required to continue this position(s): The contract amendment referenced in question 2 above, is estimated to be \$700,000. The consultants necessary for this work will not be permanent.
