REQUESTED ACTION

Authorize the New Hampshire Fish and Game Department (NHFGD) to accept and expend a total of sixty five thousand five hundred and nine dollars (\$65,509) for the purpose of implementing a new federally sponsored fellowship program; completing required compliance under Section 106 of the National Historic Preservation Act and hazardous waste assessments and abatement regarding a cabin situated on NHFGD property located in Stratham, NH; and hiring help to mark NHFGD property boundaries from date of Governor and Council approval through June 30, 2020. The funding is from two sources: fifty two thousand seven hundred and seventy dollars (\$52,770) in federal funds from the National Oceanic and Atmospheric Administration (NOAA), and twelve thousand seven hundred and thirty nine dollars (\$12,739) of federal funds from United States Fish and Wildlife Service (USFWS), 100% Federal Funds. Funds to be budgeted as follows:

EXPLANATION

This request will accept funds from a grant from NOAA to conduct education, research, training and land management functions. Beginning in FY19, there has been additional funding made available to add hours for a current part time educator to help develop new programming for high school age students. The additional NOAA funding in this request will provide temporary staff time, equipment, supplies and travel support to promote a new graduate fellowship opportunity that is available at the Great Bay National Estuary Research Reserve.

The USFWS funds will be used to complete all associated environmental compliance and remove a structure from a parcel of land that was purchased by NHFGD in 2013.

Funds are being budgeted in Class 020, Current Expenses, for supplies related to preparing to host and house a new NOAA research fellowship, and for supplies for high school and elementary school field trips.

Funds are being budgeted in Class 030, Equipment, to purchase a new office desk, bed, and computer for the new research fellow.

Funds are being budgeted in Class 041, Audit Fund Set Aside, to comply with RSA 124:16 that require all agencies which receive federal funds to set aside a percentage (.1%) of the federal revenue amount received to pay for financial and compliance audits.

Funds are being budgeted in Class 050, Personal Services Temporary, to add hours for a current seasonal, part time educator to implement new education programming for high school students and to complete an estuarine education and stewardship plan to link programming across ages at our organization and to support part time seasonal help with marking boundaries on NHFGD lands.

Funds are being budged in Class 060, Benefits, to provide required benefits associated with the Class 050 requests. Funds are being budgeted in Class 072, Grants-Federal, to provide funding to remove a structure from a parcel of state owned land.

Funds are being budgeted in Class 080, Out of State Travel, to support travel to required mentorship training and a required meeting with all National Estuarine Research Reserves in Washington, DC.

Funds are being budgeted in Class 103, Contracts for Operational Services, to complete a hazardous waste assessment, archeological and historical assessments related to land improvements planned for NHFGD owned land.
