REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Weaver Brothers Construction Co., Inc. (Vendor 154074) of Bow, NH, on the basis of a low bid of \$29,800,003.92 for Interstate rehabilitation and pavement reconstruction on I-89, from the date of Governor and Council approval through October 25, 2024, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Years 2022 and 2023, and is contingent upon the availability and continued appropriation of funds in Fiscal Years 2024 and 2025 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$2,086,000.27 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 7% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan under the Pave-T1-Rehab, Bridge T1 - 2 Rehab-Rcn and Bridge T1 - 2 Main-Pres programs. This contract consists of pavement rehabilitation of Interstate 89 (I-89) northbound (NB) and southbound (SB) from MM 24.2 to MM 31.7, including ramps at exits 10 and 11. Roadway work includes full depth pavement reclaim along the mainline and full depth pavement replacement along all ramps, including widening of acceleration and deceleration lanes. Additional work includes reconstruction of the Sutton Rest Area, replacing the NB and SB bridge decks over NH 114, guardrail replacement, tree clearing, repair and rehabilitation of drainage elements, construction of water quality treatment, and rock scaling. Installation of a Roadway Weather Information System (RWIS) and bridge preservation work are also included.

This project is one of a series of interstate rehabilitation projects along the corridor to address the condition of I-89. The overall pavement condition for the mainline is fair to poor through these project limits. Both barrels show extensive environmental (thermal) cracking, and structural (wheel path fatigue cracking) in the travel lanes and is

the main reason for rehabilitation. All existing corrugated metal pipes are being replaced or rehabilitated, and outdated guardrail hardware is being upgraded to MASH compliant systems.

The proposed contingency amount is 7% of the contract amount. This is to account for the risks associated with the limited survey information, which may result in field adjustments to the proposed work; potential for traffic control adjustments due to volume fluctuations and long duration lane closures for reclaim work; and multiple seasons of construction.

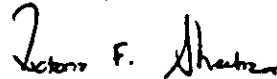
The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is a mix of 80% and 90% Federal Funds with anticipated utilization of Turnpike Toll Credits for the State's matching component effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This contract consists of pavement rehabilitation of Interstate 89 (I-89) northbound (NB) and southbound (SB) from MM 24.2 to MM 31.7, including ramps at exits 10 and 11. Roadway work includes full depth pavement reclaim along the mainline and full depth pavement replacement along all ramps, including widening of acceleration and deceleration lanes. Additional work includes reconstruction of the Sutton Rest Area, guardrail replacement, tree clearing, repair and rehabilitation of drainage elements, construction of water quality treatment, and rock scaling. Installation of a Roadway Weather Information System (RWIS) and bridge preservation work are also included on the 40511 project.

FEDERAL FUNDING:

Roadway (42419):

- 80% (Pave-T1-Rehab) with 20 % Turnpike Toll Credits for the State's match.

Bridge (40511):

- Deck Replacements: 90% (Bridge T1-2 Rehab-Rcn) with 10% Turnpike Toll Credits for the State's match.
- Other Work: 90% (Bridge T1-2 Main-Pres) with 10% Turnpike Toll Credits for the State's match.

CONTINGENCY: The proposed contingency amount is 7% of the contract amount. This is to account for the risks associated with the limited survey information, which may result in field adjustments to the proposed work; potential for traffic control adjustments due to volume fluctuations and long duration lane closures for reclaim work; and multiple seasons of construction.

PROJECT INITIATED: This project was initiated through the State's Ten Year Transportation Plan.

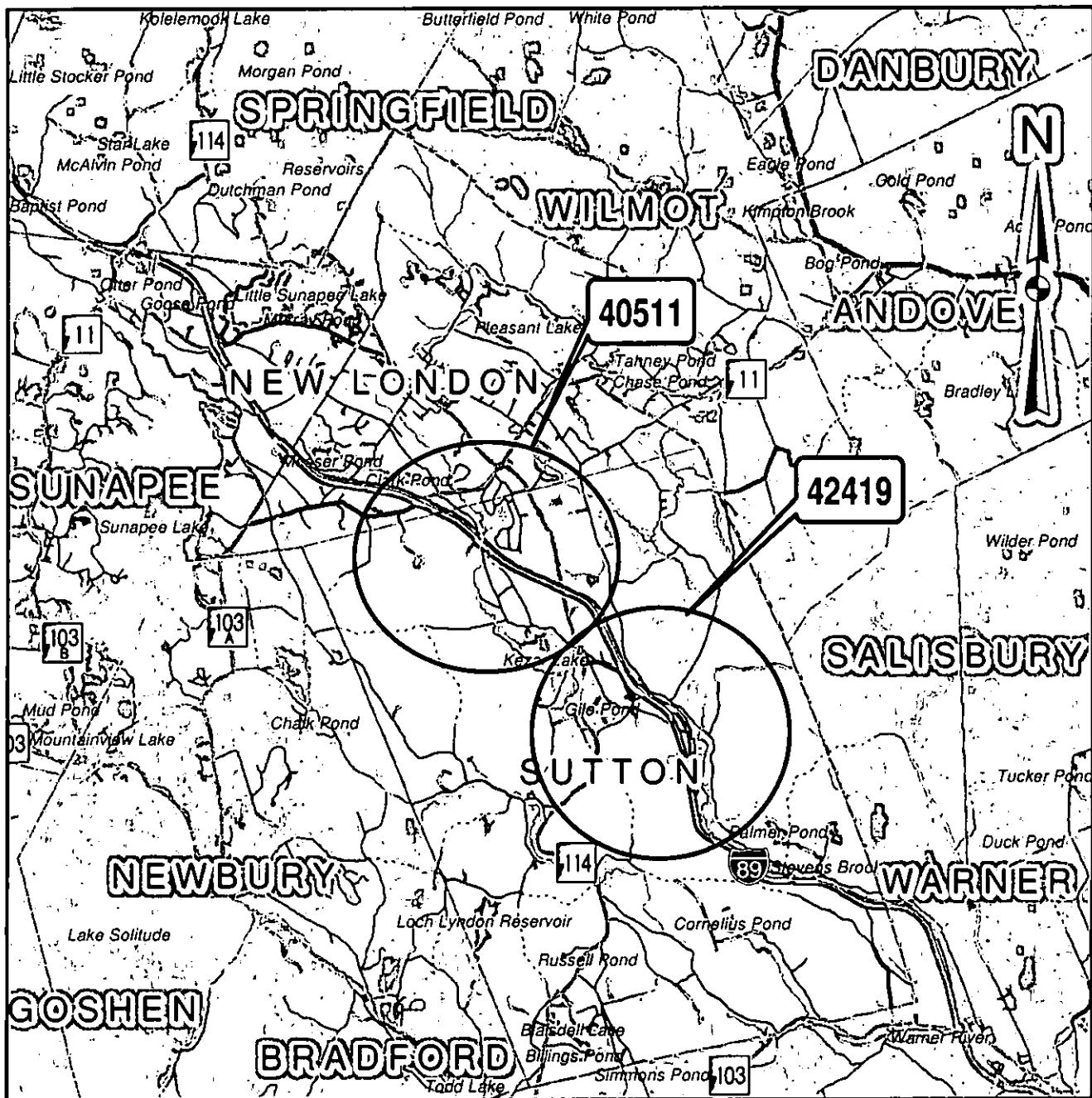
PROJECT EXPLANATION: The overall pavement condition for the mainline is fair to poor through these project limits. Both barrels show extensive environmental (thermal) cracking, and structural (wheel path fatigue cracking) in the travel lanes and is the main reason for rehabilitation. All existing corrugated metal pipes are being replaced or rehabilitated, and outdated guardrail hardware is being upgraded to MASH compliant systems.

TRAFFIC IMPLICATION: These projects were designated as "Significant Level 2" by the Traffic Control Committee. Construction activities will require lane closures delineated by traffic barrels with the exception of bridge deck replacements, which will utilize concrete barrier. No lane closures will be permitted between July 15th and September 15th. Traffic will be returned to two lanes when practical. Available roadway width will not be reduced to less than a 16' through any lane closure area, and will be accompanied by an advisory speed reduction.

Exit ramps will be permitted to close for up to 5 consecutive days, with no more than one ramp being closed at a time. The Sutton Rest Area will be permitted to be closed for up to 21 consecutive days to perform the necessary work. The bridge deck replacements over NH 114 will require the closure of NH 114 for up to 14 nights per bridge. Closures will only be permitted during nighttime hours.

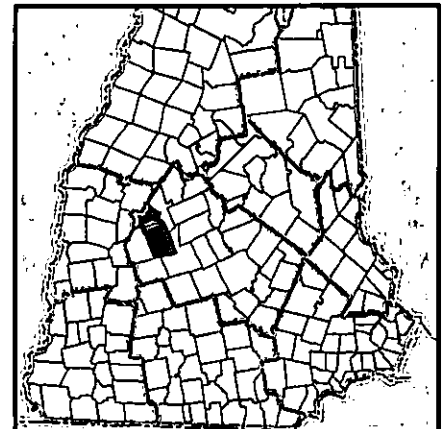

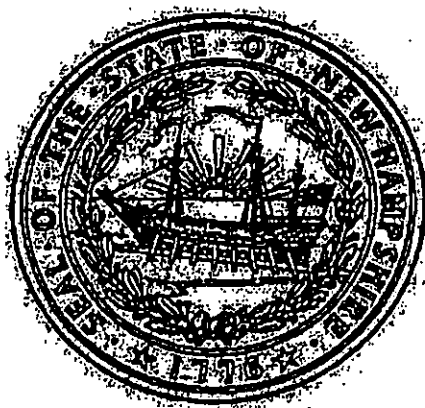
