REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Evroks Corporation (Vendor 155652) of Northfield, NH, on the basis of a low bid of \$2,242,592.25, for rehabilitation of the State Red List bridge (Br. No. 135/109) that carries NH 122 (Baboosic Lake Road) over NH 101 in Amherst (Project: Amherst 41413), from the date of Governor and Council approval through June 21, 2024, unless amended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2023, and is anticipated to be available in Fiscal Year 2024 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$224,259.26 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 10% of the contract amount.

EXPLANATION

This project is part of the State's Ten-Year Transportation Improvement Plan, under the Tier 3 & 4 Bridge Rehabilitation & Reconstruction Program. This project involves the rehabilitation of the State Red List bridge (Br. No. 135/109) that carries NH 122 (Baboosic Lake Road) over NH 101 in the Town of Amherst. The bridge is located at the NH 122 and NH 101 interchange. The work begins on NH 122 approximately 179 feet east of the bridge and continues 425 feet westerly across the bridge. The work begins on NH 101 approximately 350 feet south of the bridge and continues northerly approximately 650 feet.

The existing bridge, built in 1969, is a single-span steel stringer bridge with concrete deck and a length of 88 feet between abutments. The existing bridge deck is in serious condition with spalling concrete. The bridge has been on the Department's State Red List of deficient bridges since 2011. In 2015, the Bureau of Bridge Maintenance installed timber blocking underneath the deck. Steel debris shielding panels were installed between the girders in 2019. The bridge rehabilitation work includes replacement of the concrete bridge deck, waterproofing membrane,

and bituminous pavement; replacement of the expansion joint; replacement of the bridge rail and bridge approach rail; repairs to substructure concrete; and cleaning and painting of the structural steel and bridge shoes. Roadway work involves milling and bituminous overlay of approximately 179 feet of NH 122 east of the bridge and 154 feet of NH 122 west of the bridge. This project will remove the bridge from the Red List and extend its service life.

The proposed contingency amount is 10% of the contract amount. The following factors involve higher risks that can potentially increase costs: inability to inspect some areas of the bridge prior to removal of the bridge deck, multi-phased bridge construction, and maintenance of traffic.

Although the bid costs exceeded the Department's estimate by 39.25%, the low bid of 2 bids received is felt to be reasonable for the work involved. Four work efforts of significance accounted for 100% of the overage: bridge removal, painting structural steel (4 items), mobilization and deck concrete. This project was previously advertised for construction on September 7, 2021 and no bids were received. Re-advertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.


The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available, and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and, the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 80% Federal (Tier 3 & 4 Bridge Rehabilitation & Reconstruction (Bridg-T3-4-Rehab-Rcn)) with anticipated utilization of Turnpike Toll Credits for the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This project involves the rehabilitation of the State Red List bridge (Br. No. 135/109) that carries NH 122 (Baboosic Lake Road) over NH 101 in the Town of Amherst. The bridge is located at the NH 122 and NH 101 interchange. The work begins on NH 122 approximately 179 feet east of the bridge, and continues 425 feet westerly across the bridge. The work begins on NH 101 approximately 350 feet south of the bridge and continues northerly approximately 650 feet.

FEDERAL FUNDING: 80% (Tier 3 & 4 Bridge Rehabilitation & Reconstruction (Bridg-T3-4-Rehab-Rcn)) utilizing Turnpike Toll Credits as the State's 20% match

CONTINGENCY: The contingency amount is proposed to be 10% of the construction total. The following factors involve higher risks that can potentially increase costs: inability to inspect some areas of the bridge prior to removal of the bridge deck, multi-phased bridge construction, and maintenance of traffic.

PROJECT INITIATED: State's 10-Year Transportation Improvement Plan.

PROJECT EXPLANATION: The existing bridge, built in 1969, is a single-span steel stringer bridge with concrete deck and a length of 88 feet between abutments. The existing bridge deck is in serious condition with spalling concrete. The bridge has been on the Department's State Red List of deficient bridges since 2011. In 2015, the Bureau of Bridge Maintenance installed timber blocking underneath the deck. Steel debris shielding panels were installed between the girders in 2019. The bridge rehabilitation work includes replacement of the concrete bridge deck, waterproofing membrane, and bituminous pavement; replacement of the expansion joint; replacement of the bridge rail and bridge approach rail; repairs to substructure concrete; and cleaning and painting of the structural steel and bridge shoes. Roadway work involves milling and bituminous overlay of approximately 179 feet of NH 122 east of the bridge and 154 feet of NH 122 west of the bridge. This project will remove the bridge from the Red List and extend its service life.

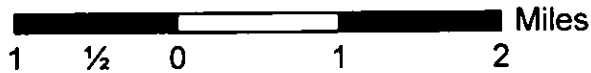
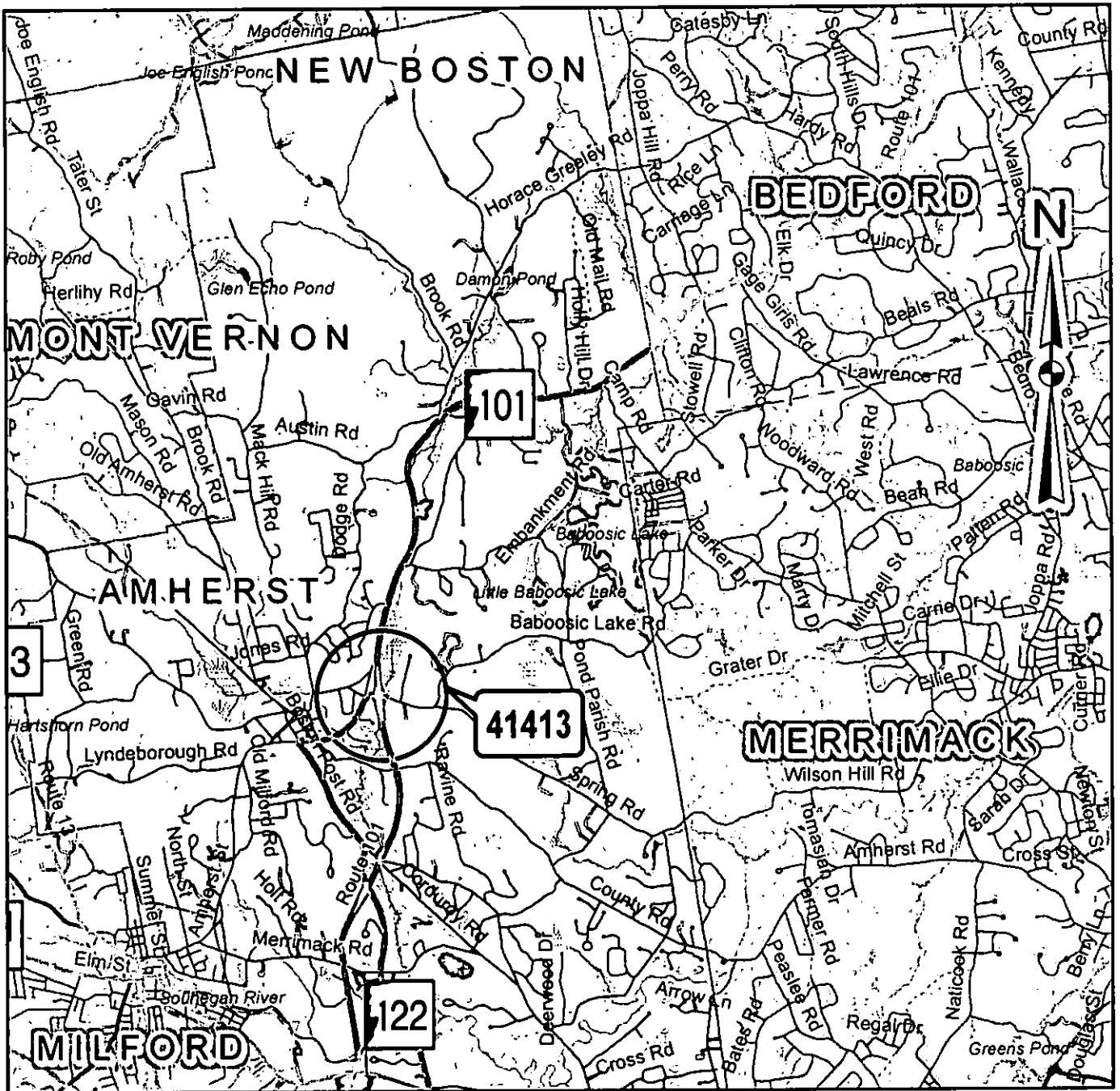
TRAFFIC IMPLICATION: The bridge rehabilitation work will be constructed in three phases while maintaining two lanes of traffic on NH 122 and full access to NH 101 interchange on-ramps and off-ramps. The bridge steel cleaning and painting operations will require lane shifts on NH 101, and some of the work will be done at night, requiring alternating two-way traffic with temporary traffic signals. Traffic on NH 101 will be restored to normal traffic patterns at the conclusion of each work shift.

INTERMEDIATE COMPLETION DATES: The intermediate completion dates are as follows:

- The bridge deck replacement will be complete with traffic on NH 122 restored to a two-lane, two-way traffic pattern by Friday, November 3, 2023.
- The bridge steel cleaning and painting will be complete by Friday, June 7, 2024.

COMPLETION DATE: The final completion date is Friday, June 21, 2024.

AMHERST - NH 122 / NH 101

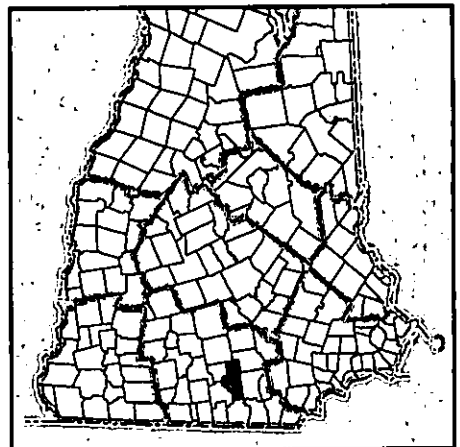


