Pursuant to MOP 1102 (L), the Department of Safety, Division of State Police, requests authorization for one Trooper to travel over 300 miles one way in a personal vehicle in the amount of \$2,392.50 to attend the FBI National Academy Associates (FBINAA) – 54th National Annual Training Conference in Quebec City, Quebec, Canada from July 20, 2018 to July 25, 2018. The round trip mileage from Concord, New Hampshire to Quebec City, Quebec, Canada is 700 miles. The Trooper will be using his personal vehicle to travel because when traveling by State Police vehicle the Trooper is required to carry his weapon and he would not be allowed to cross the Canadian border with it. The cost to travel by personal vehicle for the six-day time frame is \$2,392.50 (see Attachment A). The employee will not be paid overtime during the time frame of this travel.

The purpose of this travel is to attend the FBINAA -54^{th} National Annual Training Conference at the Quebec City Convention Centre. The Conference will feature seven keynote sessions, more than 30 plus breakout sessions and professional development seminars, and more than 100 exhibitors showcasing the latest in law enforcement and public safety products and solutions.
