### REQUESTED ACTION


For consideration to be placed on the consent calendar: Pursuant to RSA 110-B: 75, and in accordance with RSA 4:8, authorize the Adjutant General's Department to accept donations of two computers (one with a monitor, keyboard and mouse), engraving on the walkway, a pop up tent, payment of non-veteran fee and computer services in the amount of \$2,509.48 for the New Hampshire State Veterans Cemetery to be used for the operation, maintenance, and improvement of the cemetery as listed on the attachment.

### EXPLANATION
