REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Audriana Mekula Hanson to Position #9U056 (Appropriation #02-20-20-200510-26100000-013-500132) as an Attorney at a salary level of \$73,000, effective upon Governor and Executive Council approval or January 28, 2022, whichever is later.

EXPLANATION

Ms. Mekula Hanson, a Manchester resident, graduated *summa cum laude* with a Bachelor of Arts in English from Wagner College in 2014. While there, she was recognized with an Academic Activism Award and designated as Outstanding Pre-Law Student. She earned her Juris Doctor in 2018 from the University of New Hampshire School of Law, where she was a Schweitzer Fellow and Business Law Moot Court competitor. During law school, she interned with the Rockingham County Attorney's Office (2016-2017), Planned Parenthood of Northern New England (2017), Hillsborough North Superior Court (2017), and the Criminal Bureau in this office (2018). As a Daniel Webster Scholar, she was admitted to the New Hampshire Bar upon graduation. Ms. Mekula Hanson served as an Assistant County Attorney in Rockingham County from May 2018 to January 2022, where she prosecuted felony and misdemeanor crimes with a focus on domestic, intimate partner, and sexually violent crimes. In light of Ms. Mekula Hanson's experience, I am requesting she be appointed as an Attorney at a salary of \$73,000. She will be assigned to the Criminal Justice Bureau's Appeals Unit. 
