



EXPLANATION

DES needs additional funds in the expenditure classes noted above to pay for expenses incurred to operate the Winnipesaukee River Basin Program (WRBP) regional wastewater collection and treatment system. The WRBP is owned and operated by DES on behalf of the communities who rely upon the regional system. All of the WRBP's operating expenses are paid by the users of the system; there is no General Fund contribution to the system's operating budget.

As a result of the Continuing Resolution (CR) for FY20, the funds appropriated in Class 18 Overtime, Class 20 Current Expenses, Class 23 Heat, Electricity and Water, and Class 38 Technology Software, are not sufficient to meet the recurring and one-time expenses to be incurred in the first quarter of FY20. These expenditures are required for the compliant operation of these wastewater treatment facilities.

The WRBP's Class 18 overtime expenditures include the SCADA on-call time for staff monitoring operations afterhours as well as necessary responses to any alarms or emergencies. In both FY18 and FY19, the annual overtime expense was over \$80,000; over \$20,000/quarter. In less than one month in FY20 representing two pay periods, the WRBP incurred over \$4,500 in overtime expenses. Based on anticipated funding needs for the first quarter and an emergency response event in early August, an additional \$20,000 is requested for Class 18.

In addition to the various recurring expenses required for compliant wastewater operations, the costs for new compliance lab testing, which includes testing for per- and polyfluoroalkyl substances (PFAS) (\$8,500/quarter), will exceed the FY20 CR budget in Class 20. Based on anticipated funding needs for the first quarter, an additional \$8,500 is requested for Class 20.

The funds in the CR budget for the first quarter of FY20 in Class 23 Heat, Electricity and Water are not sufficient to meet the anticipated, additional expenses for fuel oil and electricity. Electricity costs are anticipated to be more than budgeted due to increased electrical costs to pump and treat wastewater during the peak summer months due to a malfunctioning heat exchanger. Additional fuel oil remains necessary to maintain constant heat in the anaerobic digesters at the Franklin wastewater treatment plant whenever methane biogas cannot be used. The Operations Building boiler must also be operated using fuel oil instead of biogas due to recurring, control system problems. This malfunctioning equipment was scheduled for replacement in the FY20 budget. Based on anticipated funding needs and the recent history of expenditures, an additional \$27,450 is requested for class 23.

The annual software license renewals for the Asset Management platform (estimated at \$40K) is due in September or else it will expire, in which case the WRBP will be unable to use this necessary software. This software is needed for the work order system whereby WRBP staff are deployed to manage WRBP assets and adequately document repair and maintenance work performed or scheduled. We have been in contact with the software vendor and they will not accept partial payments on this license renewal.

Your approval of the request will ensure that the Department meets its obligations to insure continuous and compliant operation of the WRBP.
