

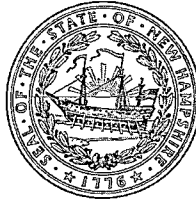

Your Excellency and Members of the Council:

**REQUESTED ACTION**

That approval be and hereby is given to the Attorney General to appoint Nicholas Chong Yen, Position # 9U615, Appropriation # 02-20-20-200510-2904-013-500132 as an Attorney, at a salary level of \$61,500, effective upon Governor and Executive Council approval or August 1, 2018, whichever is the latter.

**EXPLANATION**

Mr. Chong Yen is a resident of Lebanon, and a member of the New Hampshire Bar. He received his law degree from the University of New Hampshire School of Law in 2016, and his undergraduate degree from the University of Ottawa, in 2013. Mr. Chong Yen worked at the Hillsborough Superior Court as a Judicial Clerk from January, 2016 through April, 2016, and as an Assistant County Attorney at the Grafton County Attorney's Office from September, 2016 to the present. In view of Mr. Chong Yens' experience, I am requesting he be appointed as an Attorney at a salary of \$61,500. He will be assigned to the Drug Task Force Prosecution Unit. A copy of his resume is attached.

2001 Laws of NH Chapter 158 amended RSA 94:1-a(I)(c)(3) to provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.


