Effective upon Governor and Council approval. 100% Other Funds

## **EXPLANATION**

This request is **retroactive** because Margaret Raymond's salary increment was due on December 28, 2018, and Anthony Leone's salary increment was due on February 14, 2019. Both employees received an internal promotion while in the two-year waiting period between increments. When promoted, they were placed into a higher labor grade at a step with only a one-year waiting period. The new increment dates were not properly recorded in the system at the time.

Margaret Raymond, a 40-year employee of the Commission, is an Administrative Assistant II in the Commissioner's Office, and Anthony Leone, a 13-year employee, is a Utility Analyst III in the Gas & Water Division. Payments of \$844.88 and \$935.55, respectively, represent their prior year retroactive salary. Along with the state share of benefits due on behalf of Mrs. Raymond and Mr. Leone, the total balance owed to Mrs. Raymond is \$1015.00 and Mr. Leone is \$1123.97.

The Commission is working with the Division of Personnel and Financial Data Management to establish a complete evaluation and increment report in Excel to ensure this does not happen again in the future. Please let me know if you have any questions or need additional information.
