Dear Mr. Judd:

This is to acknowledge receipt, on October 20, 2011, of your Declaration of Candidacy to become a democratic candidate for President of the United States. We did not, however, receive the \$1,000 filing fee which is part of the filing process.

You indicate in your letter enclosed with the Declaration of Candidacy that the fee has been prepaid by U.S. Treasury checks submitted on or about October 24, 2007. I have enclosed copies of three letters dated November 20, 2007, November 26, 2007 and December 4, 2007 acknowledging receipt of U.S. Treasury checks, four in the amount of \$1,000 and one in the amount of \$5, as well as acknowledging RETURNING all of these checks via CERTIFIED mail to you. All of these checks were received in this office *after the filing period ended*. 
