REQUESTED ACTION

Authorize the Department of Health and Human Services, Bureau of Human Resource Management to make a **retroactive** one-time payment from State Fiscal Year (SFY) 2015 funds to Matthew Messier, Supervisor VI, Division for Children, Youth and Families in the amount of \$1,455.38. This payment is to compensate the employee for wages that were not paid for State Fiscal Year (SFY) 2014. The funds to be paid will be 67.96% General Funds and 32.04% Federal Funds.

EXPLANATION

This request is made retroactively because Mr. Messier was due compensation in State Fiscal Year 2014 that was not paid. The administrative error was not discovered until State Fiscal Year 2015. The Bureau of Human Resource Management has instituted a process to minimize the reoccurrence of related errors.

Mr. Messier was due an increment on November 12, 2013. Mr. Messier did have a current evaluation, however, it was placed in his file without our process being followed. Mr. Messier has been paid a partial retroactive payment but the remainder is from a prior fiscal year and requires G & C consideration. This error was just recently brought to the attention of the Bureau of Human Resource Management. Approval of this Request will rectify the error thereby allowing payment of overdue wages to Mr. Messier.
