EXPLANATION

The New Hampshire Department of Justice is seeking approval to accept and expend a grant award, entitled *New Hampshire Supporting Innovations*, received from the U.S Department of Justice Byrne-JAG Reserve Funds. These funds will be subgranted to the Manchester Police Department (MPD). These funds were not previously budgeted because the grant was awarded on a competitive basis with no guarantee that New Hampshire would receive an award.

The MPD will utilize these funds to support the purchase of a Brass-Trax Machine Acquisition Station, which includes associated fees, training, and data research. The Brass-Trax machine station allows law enforcement to submit recovered ammunition cartridge casings from crime scenes as well as cartridge casings from crime scene test fires into the National Integrated Ballistic Information Network (NIBIN). NIBIN is administered by the U.S. Bureau of Alcohol, Tobacco and Firearms (ATF). Images from ballistic evidence submitted to NIBIN can allow law enforcement to establish links between crimes.

MPD's current ability to use NIBIN is hampered by the fact that there is no NIBIN site in Northern New England. Therefore, it must submit recovered ballistics evidence by mail to the ATF Forensic Laboratory in Maryland. The Brass-Trax machine will permit direct access to NIBIN. MPD has indicated that it will serve as the NIBIN site for New Hampshire once it is acquired, thus providing access to other New Hampshire law enforcement agencies.

The performance and effectiveness of this grant will be measured as follows:

MPD will work with research partners from Southern New Hampshire University to examine success of the Brass-Trax Machine Acquisition Station to include quantitative measures of use and success coupled with a process evaluation of the effectiveness of the program's implementation with law enforcement partners.

Federal award funds are budgeted to support grant activities as follows: 040-500800-Indirect Costs . 072-500576-Federal Grant to be subgranted to the MPD to purchase the Brass-Trax Machine Acquisition Station.

In the event federal funds become no longer available, general funds will not be requested to support this program.

16. Effect of failure to address audit issues
