EXPLANATION

The Department requests authorization to transfer budgeted funds among several classes in order to pay for services incurred in meeting the State's transportation demands. Specific explanations relating to the Department's spending requests are as follows:

Administration (7022) 100% Turnpike Funds

Class 050 Decrease Personal Services - Temporary by \$15,000. Spending will be managed to accommodate this request.

Central Operations (7026) 100% Turnpike Funds

Class 050 Decrease Personal Services - Temporary by \$35,000. Spending will be managed to accommodate this request.

Central Maintenance (7027) 99.72% Turnpike Funds, .28% Agency Income

Class 050 Decrease Personal Services - Temporary by \$25,000. Spending will be managed to accommodate this request.

East NH Tpke Blue Star Operations (7031) 100% Turnpike Funds

Class 050 Decrease Personal Services - Temporary by \$25,000. Spending will be managed to accommodate this request.

East NH Tpk Blue Star Maintenance (7032) 99.55% Turnpike Funds, .45% Agency Income

Class 050 Decrease Personal Services - Temporary by \$25,000. Spending will be managed to accommodate this request.

East NH Tpke Spaulding Operations (7036) 100% Turnpike Funds

Class 050 Decrease Personal Services - Temporary by \$10,000. Spending will be managed to accommodate this request.

East NH Tpk Spaulding Maintenance (7037) 99.07% Turnpike Funds, .93% Agency Income

Class 018 Increase Overtime by \$35,000. Additional funds are needed to support anticipated winter maintenance efforts.

Class 020 Increase Current Expense by \$80,000. Additional funds are needed to support anticipated winter maintenance efforts.

Class 022 Increase Rents - Lease Other than State by \$20,000. Additional funds are needed to support anticipated winter maintenance efforts.

For budgeting purposes, the Department estimates winter maintenance over a three-year average. However, for the fiscal year 2019 budget, Spaulding Maintenance Overtime, Current (winter maintenance salt/sand supplies), and Rental Expenses (plow truck rental) were based on estimated expenditures, increasing the three-year average to include the cost of maintaining additional lane miles which Turnpikes began maintaining after the budget was requested.

The following is provided in accordance with the Budget Officer's instructional memorandum dated April 17, 1985 to support the above requested actions:

- 1. Does transfer involve continuing programs or one-time projects?

 Transfers are for continuing programs (not one-time).
- 2. Is this transfer required to maintain existing program level or will it increase program level?

 Transfers are to maintain existing program levels (no increase in program level).
- 3. Cite any requirements, which make this program necessary.
 No requirements cited.
- 4. Identify the source of funds on all accounts listed on this transfer.

 Source of funds are Turnpike Funds.
- 5. Will there be any effect on revenue if this transfer is approved or disapproved?

 This transfer will have no effect on revenue.
- 6. Are funds expected to lapse if this transfer is not approved? Funds would lapse back to the Turnpike Fund.
- 7. Are personal services involved?

 The transfer does not result in any new positions.

It is respectfully requested that this resolution be approved.
