Listed below are answers to questions which may be of assistance for The Governor and Council in considering the approval of organization dues and membership submissions:

- 1. How long has this organization been in existence and how long has this agency been a member of this organization? CLEAR began over 30 years ago; the OPLC has been a member since 2018.
- 2. Is there any other organization which provides the same or similar benefits which you agency belongs to? No
- 3. How many other states belong to this organization and is your agency the sole New Hampshire state agency that is a member? Almost all 50 states, as well as numerous international countries, states and provinces have CLEAR memberships. The OPLC is the only NH state agency that is a member of CLEAR.
- 4. How is the dues structure established? CLEAR charges states based on the number of regulated entities the agency oversees.
- 5. What benefit does the state receive from participating in membership? Membership in CLEAR provides access to regulatory resources, publications and discounts on registration to many training and conference events. The Online Board Member Training includes unlimited access of the agency's over 300 board members to the following online training: Foundations of Occupational and Professional Regulation; Roles and Responsibilities of a Board Member; Administrative Rulemaking; Professional Discipline; and Assessing Competence.
- 6. Are training or educational/research materials included in the membership? If so, is the cost included? Explain in detail: Yes, training materials are included.
- 7. Is the membership required to receive any federal grants or required in order to receive or participate in licensing or certification exams? Explain: Membership in CLEAR is not required in order to receive federal grants or to participate in examinations.
- 8. Is there any travel included with this membership fee? Explain in detail any travel to include the number of employees involved, the number of trips, destination if known and purposes of membership supported trips. No travel is included with this membership fee.
- 9. Which state agency employees are directly involved with this organization? (Indicate if they are members, voting members, committee members, and/or officers of the organization). The staff of the OPLC, specifically Directors, Board Administrators, and Board Members would be involved in CLEAR should the Governor and Executive Council approve membership.
