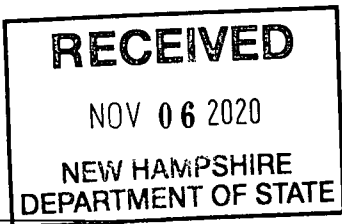

Section V
